Sealed Quotations are invited from interested Agencies/ Registered Tour Operators for providing one nos. of Non AC/AC Diesel driven Car including driver, which shall conform to the Term and conditions (Annexure-II) for official use in C.D.V.O, Office, Bhadrak on monthly rent basis.

1. The vehicle must be in Road Worthy condition shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance, Certificate, Fitness Certificate, valid Contact Carriage Permit, proof of up to date tax payment etc. which are mandatory for playing of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient nature.
4. A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee, Bank Draft drawn in favour of the CDVO, Bhadrak and submitted along with the quotation as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricant).
6. The vehicle must achieve a fuel efficiency of 17 Kms. Per litre.
7. The details of the make and year of manufacture of the vehicle, registration no., milage (Kms. Covered per litre) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation (Annexure-III).
8. The Quotation completed in all respect should reach the undersigned on or before 18.05.2018 by 10 A.M. and shall be opened on the same day at 11 A.M. in presence of the bidders or their authorized representatives.
9. The application form of quotation containing General Bid information & Terms and conditions for Hiring of Vehicle etc. will be available with CDVO Office of the Deptt./Heads of Department/ Office on payment of Rs.100/- from 09.05.2018 to 17.05.2018 or can be downloaded from Odisha Govt. website www.odisha.gov.in in case of the application from his downloaded from Govt. web site, the applicant shall furnish a Demand draft for an amount Rs.100/- (Rupees One hundred) Only towards the cost of application along with the application.
10. Preference will be give to the vehicle owners who belongs to Bhadrak District and valid registration with Bhadrak RTO Circle , if his quotation is lowest.




