- Tender documents consisting of required plans, specification, the schedule of quantities and the set of terms & conditions of contract and other necessary documents can be seen in o/o Block Development Officer, Panchayat Samiti, Dhamnagar to their related works and the office of the undersigned during office hours i.e. from **11.00 AM to 4.00 PM** every day except on Sundays and public holidays. Interested bidders may obtain further information at the same address. (NB. From 11.06.18 to 13.06.18 tender papers will be sold from 7am to 11.30 am as morning office)
- Tender must be accompanied by the Earnest money specified for the work in the table at Column 4 pledged in favour of the Block Development Officer, Panchayat Samiti, Dhamnagar, E.M.D. will have to be in forms as specified in the Detailed Tender Call Notice Clause – 7 attached with the tender. Bidders desire to hire machineries or equipments from outside the state are required to furnish 3% of the amount put to tender as security.
- The sale and receipt of the tender documents shall start from **11.06.18** and will be closed on **26.06.2018 at 4.00 PM**. Tenders shall be received in all offices where the tenders have been notified to be sold.
- The tenders will be opened on **27.06.2018 at 11.30 A.M.** in the office of the undersigned in the presence of the tenderers or their authorized agents who wish to attend. If the office happens to be closed on the last date sale, receipt and date of opening as specified, the tenders shall be sale, received and opened on the next working day at the same time and venue respectively.
- Tender papers can be purchased from all the office mentioned against the work as per table under Col. – 4 as well as the office of the undersigned against a non – refundable fee towards cost of documents as indicated in the form of cash or demand draft issued from any scheduled bank payable at Dhamnagar in favour of Block Development Officer, Panchayat Samiti, Dhamnagar or may be deposited in shape of Bank Draft prepared on or before the last date of receipt along with the tender.

7. Tender papers requested by mail will be despatched by registered / speed post on payment of an extra amount of Rs.500.00 over the cost of Tender documents. The Block Development Officer, Panchayat Samiti, Dhamnagar will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.
8. The tender (Sealed Cover) must be delivered in the tender box marked "Bid Identification No.PSD-02/2018-19" of Block Development Officer, Panchayat Samiti, Dhamnagar," failing which the tender will be rejected.
9. The tenderers shall have to furnish fresh affidavits in support of authenticity of their credentials including E.M.D along with attested/ genuineness from competent authority copies of valid & up to date GST/TIN, PAN & contractor registration certificate failing which their tenders will be rejected. The authority reserves right to verify the authenticity of documents in case of any doubt or complain.
10. If rate quoted by the bidder is less by 15% or more of the amount put to tender, then such a bid shall be rejected and tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the amount put to tender, the tender accepting authority will finalize the tender through a transparent lottery system. Further, the excess quoted rate by the bidder will not be considered as the said project was fixed budgetary provision by the Department.
11. As per works Deptt Memorandum NO 5288/W dated 04.05.2016 (A) Amendment to Para-3.5.5(V) of Note-II of OPWD code, Vol-I by modification "Additional performance security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event the bidders who have quoted less bid price /rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional performance security in shape of Post Office Savings Bank Account / National Savings Certificate / Post Office Time Deposit Account / Kisan Vikash Patra / Deposit Receipt of Scheduled Bank duly pledged in favour of the Block Development Officer, Panchayat Samiti, Dhamnagar in a separate sealed envelope along with same envelope of the original documents like paper cost, EMD etc and should be dropped in specified boxes available in the Office of the Block Development Officer, Panchayat Samiti, Dhamnagar.
The bids of the technically qualified bidders will be opened for evaluation of the price bid. In case of the bidders quoting less bid price/rate than the estimated cost put to tender and have not furnished the exact amount of differential cost (i.e. estimated cost put to tender minus the quoted amount) as additional performance security in shape of Demand Draft / Term Deposit Receipt, their price bid will not be taken in to consideration for evaluation even if they have qualified in the technical bid evaluation.
12. A bidder can submit only one tender paper for a particular work. Submission of more than one tender paper for a particular work will make liable for rejection of all such tender papers.
13. The bidder shall furnish an affidavit in support of authenticity of documents, relaxation of EMD in case of Engineer Contractor to the effect that he/she has not yet availed the facility for more than two works during the current financial year along with the bid. The name of work for which and the authority to which the tenders have been submitted must be mentioned in the affidavit, failing which the tender will be non-responsive.
14. The bidder shall have to furnish the photo copies the valid contractor registration certificate, valid VAT clearance certificate in form-612 and PAN card along with the tender failing which the tender will be rejected.
15. The Schedule Caste/ Schedule Tribe Contractors desirous to avail the facility of 10.0% price preference as per works Department Resolution No.27748 Dated 11.10.1977 should enclose the copy of their registration certificate stating the fact of caste by their registration authority and he/she also submit the affidavit to avail the facilities as fixed by Government along the with tender document, failing which he/she will not get price preference.
16. Tenderer purchasing tender paper for the second time for the same work shall have to pay the full cost of the tender paper failing which the tender will be rejected.
17. The single tender received in the first call shall be cancelled without opening the bid. The acceptance of the single tender received even after retendering should have prior approval of next higher authority vide O.P.W.D. Para-3.5.18 of Office memorandum no 16/W dated 01.01.2015.

19. The authority reserves the right to reject/ cancel any or all the tenders without assigning any reason thereof.
20. In connection with the tender called for Kalyan Mandap it is informed to the successful bidders that they would execute the work till full utilization of first phase amount mentioned against each Kalyan Mandap in column No. 3. Then the bidders will resume construction work for completion of project after confirmation received from the competent authority.
