Terms & Conditions

1. The intending tenderers interested to buy the aforesaid vehicle are required to submit their highest quotations in sealed cover with their full address in the enclosed proforma, addressed to the Project Director, DRDA, Bhadrak, At-Charigharia, P.O.-Madhabnagar, Dist.-Bhadrak, PIN-756181.
2. The sealed Quotation super scribed "Tender for sale of condemned office vehicle" on an envelope completed in all respect should reach the undersigned on or before **03.07.2018** by **1.00 PM** through Registered/Speed Post only. The Quotation will be opened at the chamber of the undersigned on the same day at **3.30 PM** in the presence of the bidder /his or her authorized person.
3. The interested bidders may submit their bid application along with EMD of **Rs 3000/- (Rupees Three thousand) only** in shape of Account Payee Bank draft drawn in favour of **BDO, Bhadrak Sadar**, payable at any Nationalized Bank/ Scheduled Banks of Bhadrak and be submitted along with the tender papers as security deposit.
4. Late/delayed & tender received without Earnest Money Deposit (EMD) in shape of Bank Draft shall not be acceptable at all.
5. The vehicle is offered for disposal on "**AS IS WHERE IS BASIS**" & no guarantee for its worthiness or quality will be given by this deptt..Taxes and duties if any that may be levied by Government will have to meet by the buyer.
6. The bidder may inspect the above vehicle on any working day from **18.06.2018 to 02.07.2018** between **10:30 am to 3.00 pm** in the premises of Bhadrak Sadar Block.
7. No Complaint whatsoever will be entertained after closing of tender. No request for inspection after submission of tender will be accepted.
8. The successful bidder shall have to deposit 25% of the bid amount immediately after announcement at the spot and rest amount within 7 days from the date of auction/approval, failing which, the aforesaid deposit of EMD will be forfeited.
9. EMD of the unsuccessful bidder will be returned immediately after finalization of the award to successful bidder. EMD of the bidder who fails to honour the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this deptt..
10. The delivery of the sold vehicle will be given only after the successful bidder submits the documentary evidence in support of residential status (Voter ID/Aadhar card/Ration card in case of individual and Registration certificate in case of firm etc.)

11. The sold vehicle shall have to be removed by the successful bidder within 7 days at his own expenses from the premises after the date of full payment of the tender amount.
12. On failure to remove the vehicle within the time as aforesaid, ground rent at the rate of 1% of the tendered/negotiated money shall be charged for each day or part of the day till removal of the vehicle from the site.
13. Where the ground rent so charged exceeds the sale price deposited, the tenderer/party shall cease to have any right on the vehicle. The amount deposited by him/her shall be adjusted towards the ground rent and the vehicle shall become absolute property of Government free from all encumbrances.
14. The EMD amount of Rs.3,000/- will be adjusted towards the sale amount.
15. The successful bidder will also be responsible for getting the registration certificate of the vehicle transferred in his name at his own cost expeditiously. This Deptt. will not be responsible for any lapse on his part in this regard.
16. The successful bidder shall not be allowed to withdraw his bid, failing which his EMD will be forfeited.
17. The scheduled day for opening the sealed tenders, if declared to be holiday due to any unforeseen reason arise, the same will be opened the next immediate working day at the same time.
18. If the highest quoting firm fails to honour the bid; the contract will be cancelled and its EMD will be forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (H-2 quoting party) to complete the bid.
19. The competent authority reserves the right to accept or reject any/all of the quotations without assigning any reason.
20. If any legal dispute arises the matter shall be settled within the jurisdiction of Bhadrak District only.
