
ENGAGEMENT OF SIKSHYA SAHAYAK(JTC), 2016-17

Pursuant to the advertisement No.12511 dated.26.12.2016, No.9836 dated.01.12.2017 & Letter No.10393 dated.09.11.2018 of OPEPA, it is hereby informed that the Draft/Provisional Merit List for 2nd phase recruitment of Sikshya Sahayak(JTC), 2016-17 on the non-joining vacancies under Bhadrak District has been published in the district official website as well as OPEPA website. The candidates including PH category enrolled in the said List shall remain present in person and produce a set of Xerox copies of all documents duly attested by them with full signature, copy of on-line application form, two recent pass port size color photograph and other required documents at District Project Office, SSA, Bhadrak on **04.12.2018 at 10.00AM** and they must be executed the agreement (module agreement copy published in website) in non-judicial stamp paper minimum worth of Rs.10/- on same day. The candidates enrolled in the PH category shall execute agreement after re-examination of their disability by the Appellate Medical Board on the specified date to be intimated later on. The candidates those have to be executed agreement on 04.12.2018, they must be participated in counseling which is to be held on the same day in office of the undersigned. The vacancies will be shown to the candidates in order of merit. However, preference will be given to the PH candidates followed by women and men candidates on merit.

The applicants who fail to production of documents, execution of agreement and participation in counseling on the scheduled date and time shall lose his/her claims for engagement as Sikshya Sahayak(JTC).

Production of documents/execution of agreement does not mean that the applicant is going to get engagement order if he/she is otherwise ineligible.

AGREEMENT

This agreement is made on this Tuesday of 4th December, 2018, between Collector-cum-Chief Executive Officer, Zilla Parishad, Bhadrak (hereinafter called the "First Party") of the one part and Smt./Sri/Kumari _____, W/o, S/o, D/o _____ aged about _____ years residing at _____, P.O.- _____, Via- _____, P.S.- _____, in the district of _____ herein after called "Second Party" of the other part.

And whereas, the Second Party is willing to be engaged as *Junior Teacher Contractual* to impart teaching in the Primary/Upper Primary Schools under School & Mass Education Deptt., Government of Odisha and to motivate the parent/guardians to send their children to schools and will be assigned such other works relating to teaching for the objective of universalisation of Primary Education and implementation of Right of Children to Free and Compulsory Education Act, 2009.

And whereas, the First Party desires to engage the Second Party on a contract basis as '*Junior Teacher Contractual*' for the period specified here under and the Second Party agreed to enter into this contract and abide by the terms and condition of this agreement.

NOW THIS AGREEMENT WITNESSED and the parties hereunder hereby agree as follows:

1. That, the First Party shall provide engagement to the Second Party as JTC in Primary/ Upper Primary schools for a period commencing on ____ day of _____, 2018 and ending on the 31st day of December, 2018 as agreed to by both the parties and the contract of this engagement ipso-facto shall be terminated on the last working day of the date specified for which no formal notice or order by the Zilla Parishad is required to be issued by the First Party. The contract will stand rescinded on expiry of the period.
2. That the Second Party shall submit himself/herself to the orders of Zilla Parishad and of the Officers/Authorities under whom he/she may from time to time be placed by the First Party and shall at all times, obey the rules prescribed and shall discharge whenever required to perform such duties as may be assigned.
3. That, the Second Party shall employ himself/herself efficiently and diligently and to the best of his/her ability.
4. That, the Second Party shall be paid Rs. 7400/- (Rupees seven thousand four hundred) only per month as consolidated honorarium.
5. That, the Second Party shall not claim the service benefits as admissible to the State Government employees.
6. That, the Second Party shall not be eligible to get any other allowance and shall not claim any other dues except the honorarium as mentioned in clause(4) above.
7. That, the Second Party shall not be eligible subject to exigency of Public Service for casual leave of 12 days during an academic year.
8. That, the Second Party shall not be entitled for any other kind of authorized absence beyond authorized leave, if he/she remains absent with permission and he/she does not have any authorized leave at his/her credit, the proportionate amount from his/her consolidated remuneration shall be deducted.
9. Teaching in the school shall be the main duty of the Second Party (JTC).

10. The Second Party must ensure Minimum Level of Learning (MLL) for the students as prescribed by the competent authority(S&ME Deptt.)
11. The Second Party must ensure at least 90% attendance of the children in respective schools in all classes.
12. The Second Party shall reduce the dropout of the children in school below 10%.
13. The Second Party would attend training programme as may be fixed by Government from time to time.
14. The Second Party shall be abide by the rationalization of teachers policy of Government as issued from time to time.
15. That, the Second Party has agreed to serve in the manner as required and perform the duties assigned by First Party and he/she has agreed to be disengaged without any notice on ground of involvement in criminal case/ misconduct/ delinquency/ incapacitation/ un-authorized absence/poor performance.
16. The engagement shall be cancelled, if any fraudulent testimonial is detected in future.

IT IS EXPRESSLY STATED AND AGREED that any duties rendered under this agreement by the Second Party shall not any circumstances what over provide him/her any right to claim for any scale of pay or to be appointed in any service that may exit now or may arise in future in any educational institutions or in any Government offices.
