

Sealed quotation/tenders are invited from interested reputed Travel Agencies/Tour Operators or private individuals for providing one number of A/C Scorpio Diesel driven vehicle(commercial) having sitting capacity not more than 10 including Driver, which shall conform to the Terms and conditions(Annexure-I) for official use of Land Acquisition Officer, Bhadrak on monthly rent basis.

1. The vehicle must be Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The driver of the vehicle must have a valid Driving License for driving transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved gentle and obedient in nature.

A sum of Rs.5,000/-(Rupees Five Thousand) only shall be deposited by the intending bidders in shape of A/C Payee Bank Draft drawn in favour of the Collector Bhadrak and submitted alongwith the tender as security deposit.
