GENERAL CONDITION OF CONTRACT

- (1) The written agreement in Municipal Form No. will to be entered into between the successful bidder here-in-after called the tenderer and the Bhadrak Municipal Council shall be foundation of the rights of both the parties and the contract shall be deemed to be incomplete until the agreement has been first signed by the contractor and then by the proper officer authorized to enter into the contract on behalf of the State Govt.
- (2) All the rates and prices in the Tender shall cover all taxes viz Central or State Sales Tax, GST, any other local taxes, ferry, tollages charges and royalties and any other charges.
- (3) The work is to be completed in all respects within the period mentioned in Tender Notice in calendar months from the date of written order to commence the work.
- (4) After opening the Tender if all Tender withdraws him/herself from the bidding during the validity of Tender. The EMD received alongwith the Tender shall be forfeited and credited to the Municipal Fund.
- (5) The Earnest Money Deposit of the unsuccessful bidder who are not awarded with the work will be refunded on application after the Tender is finalized.
- (6) Request for transfer/adjustment of Earnest Money Deposit from other works will not be entertained.
- (7) Any request from the bidder in respect of addition, alternations, modification, corrections etc. or rather terms & conditions of rates of his Tender after opening of the Tender will not be considered.
- (8) The successful bidder shall make its own arrangement for all materials T&P machineries required for satisfactory completion of work in time. Unless otherwise specified in the conditions or contract.
- (9) By submitting a Tender for the work, a bidder will be deemed to have satisfied himself by actual inspection of the site and locality of the work about the quality and availability of the required quantity of materials, medical and labour & flood stuffs etc.
- (10) The detailed list of successful bidder against each work will be displayed in the Office Notice Board. Acceptance letter of the Tender will be intimated to the successful bidder in writing. The successful bidder can collect the letter of acceptance from the office 7 (seven) days from the date of declaration of successful bidder on the Notice Board to avoid postal delay.

- (11) No escalation of cost in respect of labour, POL, materials & other item. If any will be entertained during the course of execution of work. On no account the contract work should be assigned or subject to without prior approval of Municipal Council, Bhadrak and in such event the contract may be rescinded by Executive Officer, by giving a notice in writing, the contractor should be dully liable in dimity to the municipality for any compensation payable by municipality to any quarter and in such case the same would be recovered from the contractor.
- (12) The bidder should abide by the fair wages clause notified by the Govt. in Labour Department and in force during the period of execution and shall not pay less than the fair wage fixed by Govt. to the labourers engaged by him for the work.
- (13) No claim for compensation for any damage caused by rain or any other natural calamities during the execution of work will be entertained. All safety measures are to be taken by the contractor during the execution and till final completion of work by the bidder at his own cost.
- Under two circumstances interest is chargeable to the contractor for the due or additional dues if any payable to him for the work.
- (14) The successful bidder will give two year warranty on supply items and he will give undertaking for five year free maintenance charge for Hi-Mast Light system.
- (15) Payment will be made to successful bidder after completion of work and getting certificate from an Assistant Engineer in Electrical from GED or NESCO. 5% SD will be deducted from the bill and will be refunded 1% each year.
- (16) The authority reserves the right to reject or cancel any or all the Tender without assigning any reason thereof.
