

No for providing 01 (One) no of Non-AC/AC diesel driven vehicle with sitting capacity not more than 10 including driver, which shall confirm to the terms & conditions (Annexure-11) for official use in the office of the District Manager, OSCSC Ltd, Bhadrak on monthly rent basis.

The vehicle must be in Road Worthy condition, shall not be more than 3 years of old from the date of initial registration and must have valid Registration Certificate Permit, Insurance Certificate, Fitness Certificate, Valid Contract carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The driver of the vehicle must have a valid Driving License for driving light Transport passenger vehicle and should be sufficient experienced in driving transport vehicle.
