Sealed quotations are invited from interested registered Manpower Outsourcing Agencies /Service providers having Regd. TIN/SRIN/GSTN for providing of the manpower for temporary engagement of candidates as Peon/Chowkidar & Driver in Veterinary Dispensaries/Institutions under ARD Sector of Bhadrak District on monthly remuneration of Rs.8070/- (Peon/Chowkidar) & Rs.8880/- (Driver). The out sourcing agencies may submit their quotation/Tender mentioning with terms & condition with valid licence etc. along with the photo copy of the following documents. The quotation/ Tender will be received in two bid system. One for Technical bid & another is financial bid. Earnest money of Rs.1000/- will be deposited by Services Provider and it will be returned to the bidder after finalization of the tender. The successful tender will have to deposit an amount of Rs.5000/- as security money.

- 1) GSTN clearance certificate & Manpower registration certificate
- 2) EPF / ESI registration documents
- 3) Photograph & PAN/TAN of service providing agency
- 4) Experience certificate (3 years experience in providing manpower to Govt. Department/ Public sector company)

The persons to be engaged should have the following eligibility.

- 1) Should be Indian & permanent resident of Bhadrak district.
- 2) Qualification:-Passed M.E. & able to speak ,read,& write odia language.
- 3) Should have good character & have one living spouse in case of married.
- 4) Age:- Should not less than 18 years as on. 01.01.2020 & not more than 35 years (Age relaxation may be given to departmental work experience persons).
- 5) Preference will given to the person for three years working experience in ARD Sector
- 6) Physical standard :- a) Should have good physique with minimum height of 5'(Five feet)
b) Should have know good cycling.

The service provider should have providing E.P.F./E.S.I.C facility to the beneficiaries engaged for the purpose. The candidates will be engaged at different Veterinary Institutions of Bhadrak district. The Service providers are to make payment to beneficiary in time regularly. The payment of the remuneration of the beneficiary will be paid on availability of Funds/Allotment and as per rule issued by the Govt. of Odisha from time to time.
