AND WHEREAS, U/r-2 of Odisha COVID-19 Regulation, 2020, Govt. of Odisha notified Lockdown in Bhadrak Municipal area from 7.00AM on 22.03.2020 to 9.00PM on 29.03.2020 and Health & Family Welfare Department Govt. of Odisha communicated the stipulations vide order No.8709 dated 21.03.2020.

AND WHEREAS, in exercising the powers conferred under Section-2 of the Epidemic Disease Act 1897 and in conformity with Rule-17 of guidelines issued by the Press Council of India the State Government have been pleased to issue the regulations / advisory for Prevention of Novel Corona Virus (COVID-19)

AND WHEREAS, no media shall publish the name and address of the person infected / affected with COVID-19 Virus, his/her parents relatives the Doctor treating the patient and the assisting medical staff obtained through any source in any Print/ Electronics/ Web/ Social Media.

**AND WHEREAS,** no media shall interview any patient affected with COVID-19, his/her parents relatives the Doctor treating the patient and the assisting medical staff in any form.

AND WHEREAS, any person disobeying any regulation or order made under the above provisions shall be deemed to have committed an offence punishable U/S-188 IPC as per Section-3 of the Epidemic Diseases Act 1897

AND WHEREAS, after considering the present scenario and to assure the basic essential supplies in a sustainable manner along with compliance for Social distancing principles, grocery shops having high footfall such as Reliance smart , Vishal Mega Mart, Ravi Laha store, Basanti Bhandar, and Sri Snacks shall open from 6.00AM to 10.00AM and from 4.00PM to 6.00PM from 25.03.2020. Similarly, all vegetable shops shall also be opened from 6.00AM to 10.00AM only from 25.03.2020 until further orders.

AND WHEREAS, in order to regulate the frequent & un- necessary movement of people riding two wheelers in Bhadrak Municipal area, all Petrol pumps units located in Bhadrak Municipal area (excluding those located adjacent to NH) shall issue only 1 liter petrol to the 2 wheelers at a time. CSO shall enforce the Order with immediate effect. Social distance shall be maintained at petrol pumps.

AND WHEREAS, in order to accommodate trading of various essential commodities in a dispersed manner temporarily an open space is mandatory to ensure Social Distancing between the buyers.

AND WHEREAS, in exercise of the powers conferred under Disaster Management Act-2005, Epidemic Disease Act, 1987 & the Odisha COVID-19 Regulation, 2020, the Administrative Control of Nehru Stadium is taken over from District Olympic Association for prevention and contentment of Corona Virus disease, 2019 (COVID-19)

AND WHEREAS, the District Olympic Association represented by its Secretary shall handover the stadium immediately to the District Administration represented by Executive Officer, Bhadrak Municipality.

## **OFFICE ORDER**

No. 457 /, Date. 25/03/2020

WHEREAS, Govt. of Odisha, in exercise of powers conferred u/s-2, 3 and 4 of the Epidemic Disease Act, 1987, has framed the Odisha COVID-19 Regulation, 2020 for prevention and contentment of Corona Virus disease, 2019 (COVID-19)

AND WHEREAS, Operation of high footfall of Grocery shops were restricted with timings, vide order 450 dtd 24.03.2020, high congregation of people in front left out grocery shops violating the principle of social distancing is a major concern. Considering the present scenario and to ensure basic essential supplies in a sustainable manner along with compliance to Social distancing principles, all essentials shops located within Bhadrak Municipal area otherwise allowed earlier shall function from 6 AM to 10 AM only except Medicine, Fruits, Vegetables and Milk Counters. This order shall take immediate effect till Lockdown period or 14 April 2020, whichever is later.

AND WHEREAS, all vegetable street venders functioning within Bhadrak Municipal area shall operate in Nehru Stadium by maintaining Social Distancing from Morning 6 AM to Evening 6 PM as would be regulated by Executive Officer, Bhadrak Municipality.

AND WHEREAS, this Near Total Lock down is in larger interest of the community and any one found violating the condition shall be prosecuted u/s-188 of IPC (45 of 1860).
