In Pursuance of Letter No. 8907/H dt. 23.03.2020 of Special Secretary to Govt. Health & Family Welfare Department, Odisha, Bhubaneswar & selected by the selection committee the following candidates are here by engaged as **Pharmacist** on daily wage basis @ Rs.388/- + Covid-19 incentive @ Rs.612/- total Rs.1000/- Per day for a period from the date of joining to 30.06.2020. The engagement may be extend taking in to the situation at the time & further instructions issued from the Govt. in Health & FW department. The engaged candidates are to report for duty before the **undersigned** latest by 15.04.2020 in view of COVID-19 positively failing which the engagement order stands cancelled.
