**ORDER**

Whereas, Govt. of Odisha in exercise of power conferred U/S 2,3 & 4 of the Epidemic Disease Act,1897 has promulgated Odisha COVID-19 Regulations, 2020 for Containment of COVID-19.

And Whereas, the National Disaster Management Authority, Govt. of India in exercise of power conferred U/S6(2)(l) of the Disaster Management Act,2005 has directed the State Govt./State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the National Executive Committee under the said Act to issue necessary Guidelines in this regard.

And Whereas, Govt. of Odisha has issued various measures to contain the spread of COVID-19 vide Order No. 2035/ R&DM dated 27.03.2020.

And Whereas, the Chief Secretary,Odisha has authorised Collector & D.M., Bhadrak to make any addition or alternation to the Order No.2111/R&DM(DM) /Dt.03.04.2020 on measure for containment of COVID-19 in Bhadrak District.

And Whereas, detection of three nos. of COVID-19 cases in Basudevpur & Bhandaripokhari blocks, areas where such cases have been detected and areas where people from other affected states have arrived require aggressive contact tracing, quarantine, testing and isolation as well as containment in the interest of health of general public.

Now therefore, in large public interest and with a view of contain the spread of COVID-19, we being the empowered Officer, and in continuation of this Office Order No.5651/Emg. dt.20.04.2020, hereby order that -

- a) The relaxations extended vide Order No.5650/Emg dt.19.4.2020 of Collectorate, Bhadrak shall not be applicable to in these areas until further orders.
- b) No public shall be allowed to move into & outside of the Containment area.
- c) There shall be no plying of private bikes and four wheelers except those specifically exempted and permitted as per the orders of the Hon'ble High Court.
- d) The shops dealing with essential goods/ ration shops dealing with food and grocery (daily use), hygiene items shall remain open from 6.00AM to 1.00PM.

- e) Dairy & Milk booths, poultry meat & fish, animal feed & fodder shops etc. shall operate from 6.00AM to 1.00PM
- f) Fruits & vegetable shops shall remain opened from 7.00AM to 1.00PM.
- g) All other restriction mentioned in Order No.2214 dt.17.04.2020 of SRC & ACS,Odisha, R & DM Department shall also be followed in letter & sprit.

**Any violation of this order shall entail prosecution under the penal provision of Disaster Management Act, 2005 and Section 188 of I.P.C.**
