**ORDER**

**WHEREAS**, Govt. of Odisha , Health & Family Welfare Department has promulgated the Odisha COVID-19 Regulation, 2020 where Collector has been designated as the Empowered Officer to take measures for containment of spread of COVID-19

**AND WHEREAS**, Govt. of Odisha has issued various measures to contain the spread of COVID-19 vide Order No.2035/ R & DM dt.27.03.2020.

**AND WHEREAS**, The Chief Secretary, Odisha has authorized Collector & DM, Bhadrak to make any addition or alternation to the Order No.2111/R & DM (DM) dt.3.04.2020 on measure for containment of COVID-19 in Bhadrak District.

**AND WHEREAS**, to ensure continuous supply of essential services amid strict imposition of various restrictions and keeping the public interest in mind and also for containment of spread of Corona Virus we being the empowered Officer have extended some relaxations to the people of Bhadrak District as per Order No. 2214/ R & DM dt.17.04.2020 of SRC & ACS to Govt. in R & DM Department vide this Office Order No. 5673/Emg. dt.20.4.2020.

**NOW, THEREFORE**, in addition to the aforesaid office orders & in pursuance of Order No.2267/R & DM (DM) dt.21.04.2020 of SRC & ACS to Govt. in R & DM Department and in exercising power conferred under 59(b) of National Disaster Management Act-2005, we do further order that:

1. Opening of shops of educational books are allowed from 6.00AM to 1.00PM everyday.
2. Shops selling electric fans only are allowed to remain open from 6.00AM to 6.00PM.
3. Mobile recharging centers are allowed to function from 6.00AM to 1.00PM.
4. Dhabas located in National Highways from Ranital to Akhuapada will remain open to provide only take away food. They have to provide toilet facility for costumers. All such Dhabas need to maintain hygiene & social distancing. Concerned Tahasildar shall inspect such Dhabas and report regarding toilet facility, maintenance of cleanliness of its ambience. Violation of instructions shall lead to cancellation of permission.

**The above mentioned relaxations shall not be applicable to the Containment Zones of Bhadrak District.**
