ORDER

Whereas, Govt. of Odisha in exercise of power conferred U/S 2,3 & 4 of the Epidemic Disease Act,1897 has promulgated Odisha COVID-19 Regulations, 2020 for Containment of COVID-19.

And Whereas, the National Disaster Management Authority, Govt. of India in exercise of power conferred U/S6(2)(I) of the Disaster Management Act,2005 has directed the State Govt./State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the National Executive Committee under the said Act to issue necessary Guidelines in this regard.

And Whereas, Govt. of Odisha has issued various measures to contain the spread of COVID-19 vide Order No. 2035/ R&DM dated 27.03.2020.

And Whereas, detection of +ve COVID-19 cases in **Dhamnagar** and **Tihdi** blocks, vulnerable/affected areas require aggressive contact tracing, quarantine, testing and isolation as well as containment in the interest of health of general public.

And Whereas, the Chief Secretary, Odisha has authorised Collector & D.M., Bhadrak to make any addition or alternation to the Order No.2111/R&DM(DM) /Dt.03.04.2020 on measure for containment of COVID-19 in Bhadrak District.

And Whereas, positive cases of COVID-19 are detected in Bhadrak district with recent travel history to other parts of India and to contain any possible spread of COVID-19, it is necessary to make the affected area as a containment zone and to restrict from entering into and going out of the containment zone.

The area coming with the boundary as indicated below is hereby declared as the containment zone.

- No public shall be allowed to move into the containment zone and inhabitants within the Containment Zone shall not move out.
- All the inhabitants within the containment zone shall strictly remain in home. All the shopping establishment of whatsoever nature shall be closed immediately. The supply of essential and medical requirements will be ensured through various teams formed by the District Administration.
- All the Govt. & Private Institutions located within the boundary of the containment zone is hereby closed forthwith.
- Concerned BDOs shall be the Supervising Officers of Containment Zones of their blocks.

Any violation of this order shall entail prosecution under the penal provision of Disaster Management Act, 2005 and I.P.C.
