ORDER

In partial modification of this office orders no-5799 dt 25.4.20 and 5800 dt 25.4.20, and in compliance of of the Govt. of Odisha in R&DM Order No. 2299 dtd. 25.04.2020 & in supersession to all previous Orders of this Office, **the following shops shall remain in the district except Containment Zones from 5.00 AM to 1.00 PM** daily except specifically mentioned otherwise by adhering social distancing, wearing of masks and other protocols issued by Govt. from time to time.

Shops to be opened:

1. Patho labs/Diagnostic Services (time may be extended as per requirement)
2. Grocery, Bakery, Bread /essential consumption items including personal hygiene
3. Vegetables / Non-Veg /Fruits/Eggs
4. Livestock feed
5. Books Shops for students
6. LPG Gas Agency and Transportation
7. Agriculture equipment repair shops
8. Shops selling FANs/Bulbs and other items for maintenance work
9. Mobile recharging centers.
10. Bicycle Repairing shops
11. Services /Products/processing associated with Agriculture and allied services
12. Milk & milk products shop
13. Common Service Centres
14. Medicines/Optical store (6AM to 10 PM) (medicine stores inside hospitals will remain open 24 x 7)
15. Petrol pumps (6AM To 6 PM) and those on NH will remain 24 x 7
16. Dhaba on NH side (from Ranital to Akhauapada) 24 x 7
17. Eateries /Restaurants with take away facilities only (6.00 am to 6.00 pm)

Shops not to be opened :

Tea stall/ Food stall/ Jewelry / Beauty pallor/ Salon / Gym/Fast food (Thela)/ Cloth shops/ Multi brand & single brand Malls / Pan, tobacco, Gutca, Chuingams and any food item promoting spitting and all others categories not mentioned above shall remain closed.

Advisory and other Restrictions

1. All permitted shops are encouraged to facilitate home delivery to minimize the movement individual outside the home and shall not remain open beyond time specified.
2. Big/Branded Retail outlets shall manage with 50% staff with social distancing. They shall ensure that there is no crowd in front of the shopping unit.
3. All shall wear appropriate masks.
4. Senior citizen and children are advised to stay at home and not come outside.
5. Government officials, while not on duty, cannot use bikes.
6. Private Four Wheelers not allowed.
7. Bikes not allowed except as exempted and as per orders of Hon'ble High Court. In case of exemption, pillion rider is not allowed except in case of child/PwD/patients/Women.
8. Remain at home, unless it is essential to go out.

Penal Provisions :

Any persons /entity establishments / shopkeepers violating above mentioned measures will be liable to be proceeded against as per the provisions of sections 51 to 60 of the Disaster Management Act 2005 and Covid-19 Regulations 2020 besides legal action U/S 188 IPC and other legal provisions as applicable.

This will be come to effect immediately.
