**ORDER**

In continuation to this Office Order No.5806/Emg. dt.26.04.2020 & in pursuance of Govt of Odisha in R&DM letter No. 2214/R & DM dt.17.04.2020, in order to facilitate execution of development works as permitted by Government of Odisha and wage employment activities the following addendum is hereby issued.

Depots/Stores/outlets dealing with cement, chips, rod, & other construction materials located in Bhadrak Municipality area with valid Trade License issued by Bhadrak Municipality shall remain open from 6.00AM to 6.00PM daily by adhering to social distancing , wearing of mask & other instructions issued by Govt. from time to time. Non adherence of the aforesaid advisory shall lead to closer of the shop and action as per Sec 188 of IPC.

Such units operating in the Urban Areas of Basudevpur Municipality / Chandbali NAC / Dhamnagar NAC having valid Trade License from the concerned ULBs may also function from 6.00 AM to 1.00 PM with similar stipulations.

The order will come into force with immediate effect and not applicable in CONTAINMENT ZONES.
