ORDER

WHEREAS, Govt. of Odisha in exercise of power conferred u/s 2,3 & 4 of "The Epidemic Diseases Act.1897 has promulgated "The Odisha COVID-19 Regulations.2020" for Containment the spread of COVID-19.

AND WHEREAS, the National Disaster Management Authority, Govt. of India in exercise of power conferred U/S 6(2) (I) of the Disaster Management Act, 2005 has directed the Govt./ State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the National Executive Committee under the said Act to issue necessary Guidelines in this regard.

AND WHEREAS, the social distancing is to be adhered in an effective way to minimize and contain the spread of COVID-19, the State Govt. has communicated advisory from time to time for imposing restrictions in the larger interest of Public health. The restrictions will be reviewed on a dynamic basis from time to time.

AND WHEREAS, number oftrains are coming toBhadrak Railway Station (Charampa) carryinglarge number of returnees of different Districtsfrom outside of the State on Dt. 12.05.2020 and Dt. 13.05.2020.As such, the influx of large number of people to Bhadrak Railway Stationwill create a challenge to the Administration for smooth dispersal of the returnees to their respective areas and maintenance of law & order in and around the Railway Station area with a view to contain thespread of pandemic Corona Virus Disease (COVID-19).

Keeping in view of the above facts, I, Dr.Gyana Das, IAS Collector&District Magistrate, Bhadrak in exercising the power conferredu/s 144(1)(2) of CrPC,do hereby promulgate the prohibitory orders in the following areas of Bhadrak District for immediate prevention and safeguard the life of general publicfrom 2.00PM of 12.05.2020 to2.00PM of 13.05.2020.

- Within 500 mtrs. Radius of Charampa Railway Station.
- Dagarasahi School Chhak to Ghunthunia Bazar Railway Mal-Godown Road.

- Telangasahi Gali Chhak to Kailash Film Hall Chhak.
- Charampa Over-bridge Chhak upto Xavier School Chhak. &
- Belamala to Railway Station Chhak.

The movement of individuals, all non essential activities shall remain strictly prohibited within the stipulated period. The vehicles engaged for shifting of the returnees to their destination following the principles laid down by Government of Odisha relating to COVID-19 are allowed.

The OIC of GRP Police Station, Bhadrak, IIC Bhadrak Town PS and IIC Bhadrak Rural PS are hereby directed to promulgate and enforce the above order in the prohibited area and to follow up the Law and Order situation.

This order shall come into force with immediate effect until further order and anybody violating this order shall entail prosecution under the penal provision of Disaster Management Act, 2005 & I.P.C.
