ORDER

WHEREAS, Govt. of Odisha in exercise of power conferred u/s 2,3 & 4 of the Epidemic Disease Act, 1897 has promulgated Odisha COVID-19 Regulation, 2020 for Containment of COVID-19.

AND WHEREAS, the National Disaster Management Authority, Govt. of India in exercise of power conferred u/s 6(2)(1) of the Disaster Management Act, 2005 has directed the State Govt./ State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the National Executive Committee under the said Act to issue necessary guidelines in this regard,

AND WHEREAS, Govt. of Odisha has issued various measures to contain the spread of COVID-19 vide Order No.2035/ R & DM dated 27.3.2020.

AND WHEREAS, detection of two nos. of COVID-19 cases in Bhandaripokhari Municipality and adjacent area require aggressive contact tracing, quarantine, testing and Isolation as well as containment in the interest of health of general public,

AND WHEREAS, the Chief Secretary, Odisha has authorized Collector & D.M. Bhadrak to make any addition or alteration to the Order No.2111/ R & DM dt. 3.4.2020 on measure for containment of COVID-19 in Bhadrak District,

AND WHEREAS, as per direction and guidelines the following areas of Basudevpur & Bonth Blocks were declared as Containment Zones to contain any possible spread of COVID-19 vide this Office Order No. 5824/Emg. dt.28.04.2020 to restrict the people from entering into and going out of the containment zone:

NOW, THEREFORE, as as contact tracing, quarantine, testing and isolation is completed, in larger public interest and with a view of contain the spread of COVID-19, we being the empowered Officer do hereby withdraw the order of Containment Zones in above GPs of Basudevpur & Bonth Block today i.e. on 12.5.2020.
