**ORDER**

**Whereas**, Govt. of Odisha in exercise of power conferred U/S 2, 3 & 4 of the Epidemic Disease Act, 1897 has promulgated Odisha COVID-19 Regulations, 2020 for Containment of COVID-19.

**And Whereas**, the National Disaster Management Authority, Govt. of India in exercise of power conferred U/S 6(2)(I) of the Disaster Management Act, 2005 has directed the State Govt./ State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the National Executive Committee under the said Act to issue necessary Guidelines in this regard.

**And Whereas**, Govt. of Odisha has issued various measures to contain the spread of COVID-19 vide Order No. 2035/ R&DM dated 27.03.2020.

**And Whereas**, detection of 21 (Twenty one )nos. of COVID-19 cases in Basudevpur, Dhamnagar,, Bhandaripokhari, Bonth & Chandabali Block areas require aggressive contact tracing, quarantine, testing and isolation as well as containment in the interest of health of general public.

**And Whereas**, the Chief Secretary, Odisha has authorised Collector & D.M., Bhadrak to make any addition or alternation to the Order No.2111/R&DM(DM) /Dt.03.04.2020 on measure for containment of COVID-19 in Bhadrak District.

**And Whereas**, 21 (Twenty One) nos positive cases of COVID-19 detected in afore mentioned five Blocks of Bhadrak District today having travel history from other parts of India and to contain any possible spread of COVID-19, it is necessary to make the affected areas as Containment Zones and restrict people from entering into and going out of the Containment Zone,

**Now Therefore**, in large public interest we being the empowered Officer declare the following areas as Containment Zone.

Further Maninathpur Batya Asraya Stala, Bhandaripokhari Block & Indramani High School & Bamkura High School of Dhamnagar Block which are already declared as Containment Zones vide this Office Order No.6387/Emg. Dt.14.5.2020, 6514/Emg. dt.17.5.20 & 6246/Emg. dt.8.5.20 respectively, due to detection of fresh COVID-19 cases, the period of containment in these zones is hereby extended for another 14days with effect from 19.05.2020.

- No public shall be allowed to move into the containment zone and inhabitants within the Containment Zone shall not move out.
- All the inhabitants within the containment zone shall strictly remain in home. All the shopping establishment of whatsoever nature shall be closed immediately. The supply of essential and medical requirements will be ensured through various teams formed by the District Administration.
- All the Govt. & Private Intuitions located within the boundary of the containment zone is hereby closed forthwith.
- Concerned BDO shall be the supervising Officers of Containment Zone.

**The following activities shall be carried out in the Containment Zone.**

- Contact Tracing
- Home or Institutional Quarantining of individuals based on risk assessment by Medical Officer. The risk assessment will be based on symptoms, contact with confirmed cases, and travel history.
- Testing of all cases with Severe Active Respiratory Infection (SARI), ILI and other symptoms specified by MoHFW.
- House to house surveillance by special teams constituted for this purpose.
- Clinical management of all cases as per protocol.
- Counselling and educating people; and establishing effective communication strategies.

**Any violation of this order shall entail prosecution under the penal provision of Disaster Management Act, 2005 and I.P.C.**
