ORDER

WHEREAS, Ministry of Home Affairs vide Order No. 40-3/2020/DM-I(A) dt.11.05.2020 has issued standard operation procedure for movement of persons by train and normal train operation have been partially restored with effect from 01.06.2020,

AND WHEREAS, Special Relief Commissioner and Addl. Chief Secretary to Govt. in R & DM (DM) Department has partially amended the instructions / stipulations/ relaxations mentioned in earlier Order No.2800/R & DM dated.18.05.2020 of R & DM Deptt. as communicated vide Order No.2902/ R & DM(DM) dt.24.05.2020,

NOW, THEREFORE, in pursuance of above mentioned Orders of SRC &ACS to Govt. in R & DM Deptt., we being the empowered Officer as per Disaster Management Act-2005, in supersession of this Office Order No.6626/Emg. dt.19.05.2020 do hereby issue the following revised instructions, **on Quarantine both in Rural and Urban areas. Now the quarantine period for returnee(s) will be limited to 14 days**


For Rural Areas

- i. Returnee(s) in rural areas will undergo 7 days of mandatory institutional quarantine, post which asymptomatic returnee(s) shall be discharged to undergo home quarantine for a further period of 7 days. The GPNO of the concerned TMC is the authorized officer to discharge an asymptomatic Quarantine returnee if he does not have any symptoms.
- ii. Period of institutional quarantine of the returnee(s).shall be extended for reasons related to COVID -19.
- iii. In case the quarantinee develops symptoms requiring medical attention, he/she shall be shifted to COVID Care Centre/COVID Hospital GPNO shall report the matter immediately to the Block Development Officer and take step for their shifting.

For Urban Area

- i. In Urban areas every person on return from outside Odisha shall have to compulsory stay in home quarantine for a period of 14 days, observing guidelines issued by H&FW Deptt., Govt of Odisha. If the returnee does not have proper quarantine facility at home, he/she shall undergo institutional Quarantine for 14 days. For institutional quarantine or for paid hotel accommodation, the returnee concerned may contact the local Executive Officer.

This order shall come into immediate effect and shall not be applicable in Containment Zones.
