ORDER

WHEREAS, Ministry of Home Affairs vide Order No. 40-3/2020/DM-I(A) dt.11.05.2020 has issued standard operation procedure for movement of persons by train and normal train operation have been partially restored with effect from 01.06.2020,

AND WHEREAS, Special Relief Commissioner and Addl. Chief Secretary to Govt. in R & DM (DM) Department has partially amended the instructions / stipulations/ relaxations mentioned in earlier Order No.2800/R & DM dated.18.05.2020 of R & DM Deptt. as communicated vide Order No.2902/ R & DM(DM) dt.24.05.2020,

NOW, THEREFORE, in pursuance of above mentioned Orders of SRC & ACS to Govt. in R & DM Deptt., we being the empowered Officer as per Disaster Management Act-2005, in supersession of this Office Order No.6626/Emg. dt.19.05.2020 do hereby issue the following revised instructions,

The following activities shall be permitted with restrictions except in Containment Zones:

- i. Intra-State Movement of two wheelers, private vehicles, Official vehicles, taxis (including cabs by aggregators like Ola, Uber etc). Four wheelers and Auto Rickshaws up to 2 (two) passengers apart from the driver.
- ii. Intra-State Buses, other Passenger vehicles and City Buses are allowed to operate up to sitting capacity of the vehicle. No passenger beyond the seat capacity is permissible.
- iii. Intra-State trains are allowed to operate following the SOP of MHA and Indian Railways.
- iv. Movement of public Transport, private vehicles and taxis(including cabs by aggregators like Ola, Uber etc.) to and from airports, railway station and bus terminals/stands/stops are allowed, for facilitating movement of passengers by air, rail and road.
- v. Auto & Cab services are allowed round the clock at Bhadrak Railway Station at Charampa and New Bus stand, Bhadrak, Bus stand near Bonth chhakoperated earlier is not permitted untill further orders.
- vi. All passengers travelling across the State by any mode of transport shall compulsorily wear masks and persons with visible symptoms will not be permitted board.

This order shall come into immediate effect
