


1. The sealed tender is closed cover super scribed by "TENDER FOR VEHICLE" will receive in the office of the Deputy Director (P &S), DPMU, Statistical wing, Bhadrak on or before 30.07.2020 during the working hours. The tender so received will be opened on DT 31.07.2020 at 2 PM by the Deputy Director (P&S) and Asst. Director (statistics) in presence of tenders in the office of the undersigned.
2. The intending bidders may inspect the vehicle during office hours.
3. Intending bidders shall have to enclose a bank draft of Rs 1000/- (Rupees one thousand) only drawn on the state bank of India , Bhadrak in favour of Deputy Director (P&S), DPMU, Bhadrak towards EMD for the vehicle along with the tender paper failing which the tender will be not accepted .
4. The EMD of Rs 1000/- of the unsuccessful tendered shall be refunded to them on the day of opening tender paper.
5. The tender quoting highest price shall deposit 25% of the accepted price immediately on conformation of acceptance of tender and rest amount within 7 (seven) days. In case of failure to pay the amount the deposit including earned money will be forfeited and the vehicle will be put to fresh tender.
6. The vehicle will be handed over to the successful render after making the full payment of the accepted tender money.
7. The tender will remove the vehicle from the site within 7 (seven) days of payment of money in full. The safeguard and custody of the vehicle shall be the responsibility of the tender No claim or complain in this regards shall be entertained by the undersigned.


