**ORDER**

**Whereas** it is imperative to adopt strict social distancing and isolation measures to contain the spread of COVID-19, which is playing havoc in many countries across the world, including India,

**And Whereas**, the Government of Odisha, vide Revenue & DM (Disaster Management) Department Notification No.1706/R&DM(DM) dated 13th March 2020, has declared COVID-19 as a 'Disaster' under section 2(d) of the Disaster Management Act, 2005 for the State of Odisha;

**And Whereas**, the Government of Odisha, in exercise of powers conferred under section 2 of the Epidemic Disease Act, 1897 and the Odisha COVID-19 Regulation, 2020 has ordered lockdown of the entire State vide order No. 3057/R&DM(DM) Dated 01.06.2020 till midnight of 30<sup>th</sup> of June, 2020,

**And whereas**, detection of significant numbers of COVID-19 cases in the districts of Bhadrak in last few days requires aggressive contact tracing, quarantine, testing and isolation as well as containment in the interest of health of general public ;

**And whereas**, the State Disaster Management Authority (SDMA) has authorized the Chief Secretary of the State to make any addition or alteration to the Order No.2035/R&DM(DM) dated. 27.03.2020 on measures for containment of COVID-19 in the State;

**And whereas**, the weekend shut down in Bhadrak District already in force vide this Office Order No. 9084/Emg. dt.06.07.2020,

**And whereas**, a significant rise in COVID-19 cases has been reported from Dhamnagar NAC Area since last few days,

**Now therefore**, in large public interest and in continuation of afore mentioned weekend Office Order it is hereby ordered that:

**There shall be 72 hours complete shut down in Dhamnagar NAC. The shutdown will be effective from 5.00AM of Friday i.e. 17.07.2020 to 5.00AM of Monday i.e on 20.07.2020.**


During this shutdown period, **all other activities/ Institutions including all Govt offices within the area of Dhamnagar NAC** shall remain closed with the following exceptions:

- All medical establishments including hospitals, clinics, nursing homes, Including medicine stores. Movement of Ambulance and all medical personnel.
- Block, Tahasils and Municipal Administration/ Police/Fire Services
- Central&StateGovernmentofficialsonemergencyduty
- Telecomservices
- Petrolpumps

- Print and Electronic Media identified by SP, Bhadrak
- Water Supply, sanitation and sewerage workers
- Electricity supply and distribution
- Movement of goods and good carriers, whether loaded or unloaded
- Industrial establishments, factories and related construction activities
- All Agriculture, Horticulture & Allied activities
- All Dairy, Fisheries, Animal Husbandry and Allied activities
- Road movement of transiting vehicles
- Movement private vehicles and taxis (including cabs by aggregators like Ola, Uber, etc.) to and from railway station and bus stands, for facilitating movement of passengers by rail and road.
- Marriages and funerals, with permission from local Police Station
- Safety and protection of vulnerable persons
- Movement of any person in case of medical or other emergency
- ATMs and critical financial institution
- Newspapers hawkers between 5am and 8 am only
- LPG distribution, home delivery of cooking gas and associated facilities, personnel and vehicular movement.

**N.B:** The officials engaged in emergency duty or associated with essential public services shall display a copy of office order issued by District Administration/ Head of Office, on their vehicles / carry it along with them while move out.

Any violation of this order shall entail prosecution under the penal provisions of Disaster Management Act, 2005 and Sec 188 of IPC.
