WHEREAS, Govt. of Odisha in exercise of power conferred u/s 2,3 & 4 of "The Epidemic Diseases Act.1897" has promulgated "**The Odisha COVID-19 Regulations.2020**" for Containment the spread of COVID-19.

AND WHEREAS, the National Disaster Management Authority, Govt. of India in exercise of power conferred U/S 6 (2) (1) of the Disaster Management Act, 2005 has directed the Govt./ State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the National Executive Committee under the said Act to issue necessary Guidellnes in this regard.

AND WHEREAS, The State Government of Odisha, vide their order No.3856/R&DM Date-30.06.2020 of State Relief Commissioner & ACS has also issued guidelines for extended the lock down in the entire state of Odisha to contain the spread of pandemic Corona Virus Disease (Covid-19).

AND WHEREAS, the social distancing is to be adhered in an effective way to minimize and contain the spread of COVID-19; the State Govt. has communicated advisory from time to time for imposing restrictions in the larger interest of Public health. The restrictions will be reviewed on a dynamic basis from time to time. Whereas a significant rise has been observed in Several Blocks of Bhadrak District in last few days, after due assessment it is felt to impose a stricter **CURFEW** order in those area.

NOW THEREFORE, in partial modification this office order No.653/Judl. 30/06/2020 and keeping in view of the above facts, I, Dr. Gyana Das IAS Collector & District Magistrate, Bhadrak in exercising the power conferred **u/s 144(1)(2) of CrPC**, do hereby promulgate the prohibitory orders in the Revenue District of Bhadrak for immediate prevention and safe-guard the life of general public from **17.07.2020 to 31.07.2020 midnight**.

All shops, commercial establishments, Offices, institutions shall remain closed at 5.00PM everyday throughout the District, and the movement of individuals shall be prohibited from 6.00PM to 5.00AM except for the following essential activities.

- 
- District and Municipal Administration/ Police/ Government Officials on duty
 - Doctors, Medical/ Paramedical Staff (Govt. & Private)
 - Staff of IT & ITEs Companies on production their I-card
 - Any person, in case of medical or other emergency
 - Owner/ staff of Chemist shops
 - All Industrial units, all construction activities.
 - Movement of Public Transport, private vehicles and taxis (including cabs by aggregators like Ola, Uber, etc.) to and from railway station and bus terminals/ stands/ stops, for facilitating movement of passengers by rail and road.
 - Dhabas along National and State Highways/ Major roads for takeaway only.
 - Medical store to open till 10.00PM & medical stores within the premises of Hospital will open 24X7.

This order shall come into force with immediate effect and anybody violating this order shall entail prosecution under the penal provision of Disaster Management Act, 2005 & U/S 188 of I.P.C.
