ORDER

Whereas, Govt. of Odisha in exercise of power conferred U/S 2, 3 & 4 of the Epidemic Disease Act, 1897 has promulgated Odisha COVID-19 Regulations, 2020 for Containment of COVID-19.

And Whereas, the National Disaster Management Authority, Govt. of India in exercise of power conferred U/S 6(2)(I) of the Disaster Management Act, 2005 has directed the State Govt./ State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the National Executive Committee under the said Act to issue necessary Guidelines in this regard.

And Whereas, Govt. of Odisha has issued various measures to contain the spread of COVID-19 vide Order No. 2035/ R&DM dated 27.03.2020.

And Whereas, the Chief Secretary, Odisha has authorized Collector & D.M., Bhadrak to make any addition or alternation to the Order No.2111/R&DM(DM) /Dt.03.04.2020 on measure for containment of COVID-19 in Bhadrak District.

And Whereas, detection of 02 (Two) nos. of COVID-19 positive cases in Bhadrak Municipality area and 01 COVID-19 positive case in Bonth Block requires aggressive contact tracing, quarantine, testing and isolation as well as containment in the interest of health of general public.

Now Therefore, in large public interest we being the empowered Officer , the **Ward No.6 (Mathasahi) of Bhadrak Municipality area and Vill-Saharpada of Ramchandrapur GP of Bonth Block** which were already declared as Containment Zones earlier vide this Office Order No.9984/Emg. Dt.27.07.2020 and 9908/Emg Dated 24.07.2020 respectively. Due to detection of 03 nos. of fresh COVID-19 cases, the period of containment in the aforesaid areas **are hereby extended for another 14 days with effect from 29.07.2020.**

- No public shall be allowed to move into the containment zone and inhabitants within the Containment Zone shall not move out.
- All the inhabitants within the containment zone shall strictly remain in home. All the shopping establishment of whatsoever nature shall be closed immediately. The supply of essential and medical requirements will be ensured through various teams formed by the District Administration.
- All the Govt. & Private Intuitions located within the boundary of the containment zone is hereby closed forthwith.
- Executive Officer, Bhadrak Municipality and BDO, Bonth shall be the supervising Officers of the aforesaid Containment Zones.

The following activities shall be carried out in the Containment Zone.

- Contact Tracing
- Home or Institutional Quarantining of individuals based on risk assessment by Medical Officer. The risk assessment will be based on symptoms, contact with confirmed cases, and travel history.
- Testing of all cases with Severe Active Respiratory Infection (SARI), ILI and other symptoms specified by MoHFW.
- House to house surveillance by special teams constituted for this purpose.
- Clinical management of all cases as per protocol.
- Counseling and educating people; and establishing effective communication strategies.

Any violation of this order shall entail prosecution under the penal provision of Disaster Management Act, 2005 and I.P.C.
