ORDER

Whereas, detection of significant numbers of COVID-19 cases in the districts of Bhadrak in last few days requires aggressive contact tracing, quarantine, testing and isolation as well as containment in the interest of health of general public ;

And whereas, the weekend shut down in all seven Block & four Urban Local Body Hqrs of Bhadrak District is already in force vide this Office Order No. 9084/Emg. dt.06.07.2020, & No.9829/Emg. dated.22.07.2020 respectively,

And Whereas, after due reassessment of situation regarding outcome of imposition of lock down has been made by District Administration,

Now therefore, in large public interest, to curb further spread of COVID-19 and we being the authorized officer do hereby order that **there shall be 48 hours complete shut down in whole of Bhadrak Revenue District for two days i.e.from 5AM of 01.08.2020 to 5AM of 03.08.2020**

During this shutdown period, **all other activities/ Institutions** including all Govt. Offices of **Bhadrak District** shall remain closed with the following exceptions:

- All medical establishments including hospitals, clinics, nursing homes, Including Movement of Ambulance and all medical personnel.
- Medicine Store upto 10 PM and Medical Store at DDH and CHC (24 x 7) District and Municipal Administration/ Police/Fire Services
- Central & State Government officials on emergency duty
- Telecom ATMs
- Petrol pumps
- Print and Electronic Media identified by SP, Bhadrak
- Water Supply, sanitation and sewerage workers
- Electricity supply and distribution
- Movement of goods and good carriers, whether loaded or unloaded
- Industrial establishments, factories and related construction activities
- Service sector industries, including IT/ITeS, Hotel & Hospitality Units
- All Agriculture, Horticulture & Allied activities including opening of Fertilizers and Pesticides Shops

- All Dairy, Fisheries, Animal Husbandry and Allied activities
- Movement of rail
- Road transport on highways, road movement of transiting vehicles
- Movement of Public Transport, private vehicles and taxi stand from railway station and bus stands, for facilitating movement of passengers by rail and road subject to protection of valid documents.
- Marriages and funerals, with permission by Local police station.
- Safety and protection of vulnerable persons
- Movement of any person in case of medical or other emergency
- Operations of Railway Stations, Bus Terminals and their associated offices, movement of associated personnel and activities
- LPG distribution, home delivery of cooking gas and associated facilities, personnel and vehicular movement.
- Tyre repairing shops at National Highway

N.B: The officials engaged in emergency duty or associated with essential public services shall display a copy of office order issued by District Administration/ Head of Office, on their vehicles / carry it along with them while move out.

Any violation of this order shall entail prosecution under the penal provisions of Disaster Management Act, 2005 and IPC.

This will come into effect from 5AM of 01.08.20 to 5AM of 03.08.20
