ORDER

Whereas, Govt. of Odisha in exercise of power conferred U/S 2, 3 & 4 of the Epidemic Disease Act, 1897 has promulgated Odisha COVID-19 Regulations, 2020 for Containment of COVID-19 pandemic in the State.

And Whereas, the National Disaster Management Authority, Govt. of India in exercise of power conferred U/S 6(2) (I) of the Disaster Management Act, 2005 has directed the State Govt./ State Authorities to take necessary measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the National Executive Committee under the said Act to issue necessary Guidelines in this regard.

And Whereas, Govt. of Odisha has issued various measures to contain the spread of COVID-19 vide Order No. 2035/ R&DM dated 27.03.2020.

And Whereas, the Chief Secretary, Odisha has authorized Collector & D.M., Bhadrak to make any addition or alteration to the Order No.2111/R&DM(DM) /Dt.03.04.2020 on preventive measures for containment of COVID-19 in Bhadrak District.

And Whereas, detection of following new COVID-19 positive cases as local contact/local positive contact in different areas/TMCs of Block/ULBs of Bhadrak district requires intensive contact tracing, house-to-house surveillance, quarantine, testing, isolation and other clinical interventions as per the extant guidelines issued by MoHFW/H&FW Department.

Now, Therefore, in pursuance of the said guidelines, in larger public interest, we being the empowered Officer on assessment of the situation do hereby promulgate following orders in the said affected areas in order to contain the spread of Covid-19 pandemic.

1. Declaration of new Containment Zones (**ANNEXURE-A**)
 2. Declaration of extension of period at existing Containment Zones (**ANNEXURE-B**)
 3. De-notification of Containment Zones (**ANNEXURE-C**)
 4. Declaration of new and extension of containment zones at TMCs (**ANNEXURE-D**)
- No public shall be allowed to move into the containment zone and inhabitants within the Containment Zone shall not move out.
 - All the inhabitants within the containment zone shall strictly remain in home. All the shopping establishment of whatsoever nature shall be closed immediately. The supply of essential and medical requirements will be ensured through various teams formed by the District Administration.
 - All the Govt. & Private Intuitions located within the boundary of the containment zone is hereby closed forthwith.
 - Concerned Executive Officers and BDOs of respective ULB/Blocks shall be the Supervising Officers of the aforesaid Containment Zones under their jurisdiction.

P.T.O

The following activities shall be carried out in the Containment Zone.

- Intensive Contact Tracing
- Home or Institutional Quarantining of individuals based on risk assessment by Medical Officer. The risk assessment will be based on symptoms, contact with confirmed cases, and travel history.
- Testing of all cases with Severe Active Respiratory Infection (SARI), ILI and other symptoms specified by MoHFW.
- House-to-house surveillance by special teams constituted for this purpose.
- Clinical management of all cases as per protocol.
- Counselling and educating people; and establishing effective communication strategies.

No. of persons undergoing Institutional Quarantine at the venue shall not be released till the Containment Zone is de-notified.

Any violation of this order shall entail prosecution under the penal provision of Disaster Management Act, 2005 and Section 188 of I.P.C.
