In Pursuance of Letter No.16705/H&FW dt.14.07.2020 of Addl. Chief Secretary to Govt. Health & Family Welfare Department, Odisha, Bhubaneswar & selected by the selection committee the following candidates are selected for temporary engagement in daily wage basis @ Rs.388/- + Covid-19 incentive @ Rs.462/- total Rs.850/- Per day as per ESI Dept. Notification No.11688/LCD dt.07.11.2019 with special incentive for COVID-19 are hereby engaged at COVID CARE HOMES/COVID GRUHAS against each panchayat as mentioned below against their name for a period of three months only or till CCHs are functional whichever is earlier in view of emergency situation arising due to Covid-19... The engaged candidates are to report for duty before the concerned Superintendent of CHCs as mentioned against the name latest by 16.09.2020 in view of COVID-19 positively failing which the engagement order stands cancelled. No further correspondence is allowed.

The engagement is on daily wages basis and is purely temporary. The candidates can not claim further engagement in the department after present engagement is over.

They should furnish an undertaking at the time of joining that the assignment is fixed on daily wages and it does not confer any right for regular or re-engagement after termination/retranchment or end of present engagement.
