Sealed Quotation/ Tender are invited from local reputed Travel Agencies/Private individuals for providing 01 (one) no of Non AC/AC Diesel driven vehicle having sitting not more than seven including driver which shall confirm to the Terms and Conditions (Annexure-II) in the Office of the District Manager OSCSC Ltd., Bhadrak to engage on monthly rent basis for supervision of Paddy Procurement Operation during KMS 2020-21 subject to receipt of approval from Corporation Head Office.





TERM & CONDITIONS FOR HIRING OF VEHICLE

The following terms & conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicle during period of contract shall have all necessary valid MV documents such as valid Registration Certificate , Insurance Certificate, Fitness Certificate, Valid Contract Permit, proof of up to date tax payment etc and DL of the driver available all the times. The Office of the District Manager, OSCSC Ltd, Bhadrak hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles or loss of life/injury made to any person or damage to any property on account of use of hired vehicle any manner what so ever. The hirer shall be responsible for all such litigation.
2. The hire charges to be paid for monthly basis is final but does not include cost of diesel and lubricants. All the expenditure of the vehicle towards repair, replacement of spare parts. Lubricating oil of engine, Gear box & different Coolant, tyres & Tubes, Battery etc will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
4. In case of breakdown for reasons whatsoever the replace of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
5. In case of the vehicle do not report regularly , the authority will be at liberty to reject the agreement and may engage vehicle from other source.
6. The vehicle shall report for duty for minimum of 25 days in month.
