ORDER

WHEREAS, Govt. of Odisha in exercise of power conferred u/s 2,3 & 4 of “**The Epidemic Diseases Act.1897**” has promulgated “**The Odisha COVID-19 Regulations.2020**” for Containment the spread of COVID-19.

AND WHEREAS, the National Disaster Management Authority, Govt. of India in exercise of power conferred U/S 6 (2) (I) of the Disaster Management Act, 2005 has directed the Govt./ State Authorities to take measures for ensuring social distancing so as to prevent the spread of COVID-19 and directed the National Executive Committee under the said Act to issue necessary Guidelines in this regard.

AND WHEREAS, the State Government of Odisha, vide their order No.7384/R&DM(DM) Date-30.12.2020 of Chief Secretary, Odisha has issued guidelines for extending the lock down in Containment Zones only and re-opening more activities outside the Containment Zones with effect from 01.01.2021 to 31.01.2021.

AND WHEREAS, Govt. has further issued Order No.7380/R & DM(DM) dt. 30.12.2020 of Chief Secretary Odisha & Chairperson, State Executive Committee prohibiting congregation in public places & banned zero-night celebrations in the eve of New Year-2021, in order to contain the threat of mutant variety of Corona virus/pandemic Covid-19.

NOW THEREFORE, in pursuance of above mentioned orders & keeping in view of the above facts, I, Dr. Gyana Das IAS Collector & District Magistrate, Bhadrak in exercising the power conferred **u/s 144(1)(2) of CrPC**, do hereby promulgate the prohibitory orders (Curfew) in the Bhadrak District for immediate prevention and safe-guard the life of general public **from 10.00 PM of 31.12.2020 to 5.00 AM of 01.01.2021.**

All hotels, parks, Clubs, Restaurants, Convention Halls, shops, commercial establishments, Offices, institutions shall remain closed from **10.00PM of 31.12.2020 to 5.00 AM of 01.01.2021.** However the essential activities or duty of emergency nature shall be allowed during the curfew period.

All IICs/OICs of Bhadrak district are hereby directed to promulgate and enforce the above order in their respective police station areas and to follow up the Law and Order situation.

This order shall come into force with immediate effect and anybody violating this order shall entail prosecution under the penal provision of Disaster Management Act, 2005 & I.P.C.
