ORDER

In partial modification of this Office Order No.14810/Emg dt.31.12.2020 and Order No.7395/R & DM(DM) dt.31.12.20 & Order No.7399/ R & DM (DM) dt.31.12.20 of SRC & ACS to Govt. (Disaster Management) Odisha, Bhubaneswar regarding imposition of curfew in the eve of New Year celebration, it is further ordered that the following activities shall be allowed during the period of curfew i.e. from **10.00PM of Dt. 31.12.2020 to 5.00AM of Dt.01.01.2021.**

- i. District & Municipal Administration/ Police/ Fire Services/ Other State/ Central Govt. Offices/ Official on emergency duty.
- ii. Defence/ Central Armed Police Forces on duty.
- iii. All Medical establishments including Govt. and private hospitals, clinics nursing homes, including medicine stores.
- iv. Movement of ambulance and all medical personnel including Doctors & Paramedics on duty; Owner/ Staff of chemist shops
- v. Any person on medical or other emergency
- vi. Staff of IT & ITes companies on production of their ID cards
- vii. Telecom Services including their maintenance Offices and movement of associated personnel.
- viii. Early warning Agencies including IMD
- ix. Disaster Management Establishments
- x. Water supply, Sanitation and sewerage workers on duty
- xi. Power generation, transmission and distribution
- xii. Movement of Rail transport, operations of Railway Stations, Bus Terminals and their associated Offices, movement of associated personnel and activities
- xiii. Movement of transiting vehicles on highways
- xiv. Movement of goods and goods carriers, whether loaded or unloaded
- xv. Movement of public transport, private vehicles and taxis to and fro from railway station.
- xvi. Petrol pumps and LPG including their distribution and retail outlets.
- xvii. Media houses and movement of representatives of Print and electronic media on duty.

All IICs/OICs of Bhadrak district are hereby directed to promulgate and enforce the above order in their respective police station areas and to follow up the Law and Order situation.

***This order shall come into force with immediate effect and anybody violating this order shall entail prosecution under the penal provision of Disaster Management Act, 2005 & I.P.C.***
