ORDER

Whereas, State Govt. vide Order No.7384/R & DM (DM) dt. 30.12.2020 of Chief Secretary, Odisha have Ordered to reopen more activities in areas outside Containment Zones up to 31.01.2021 and District Collectors have been authorized to accord permission for opening Cinema Halls /Theaters / Entertainment Parks etc. with appropriate restrictions to curb spread of COVID-19,

Now Therefore, after due assessment of ground level situation and consultation with relevant stake holders it is hereby ordered that all cinema halls /Theaters / Entertainment Parks etc in Bhadrak district shall be opened to public with effect from 08.01.2021 with strict observance of SOP issued by Govt. and COVID-19 safety protocol.

1. All Cinema halls/ Theaters / Entertainment Parks will be reopened from 08.01.2021 with up to 50% of sitting capacity.
2. Wearing of mask appropriately by the spectators at all times.
3. Social distancing mandatorily maintained with inside and outside (within the premises) of the cinema halls /Theaters / Entertainment Parks.
4. Hand sanitizer facility to be provided by the cinema hall / Entertainment Park authorities.
5. Spitting inside & outside and chewing of PAN / Ghutka within the premises of cinema hall / Entertainment Park are strictly prohibited.
6. The person with COVID-19 like symptoms shall not be allowed to enter into the, cinema hall / Entertainment Park.
7. Participants who have returned from overseas shall have to abide by the protocols for quarantine / isolation issued by Govt. of India/ Govt. of Odisha from time to time before visiting the cinema hall / Entertainment Park.

8. It is the duty and responsibilities of the owner of the cinema hall and Theatres and the caretaker of the parks to maintain all COVID protocols in letter and spirit without any deviation. They need to arrange seats / space accordingly before opening of the Cinema hall, theater and Entertainment Park.
9. The local Tahasildars/ Executive Officer and Police shall make surprise checking of these places and ensure strict adherence to COVID-19 protocols.
10. The above conditional permission to be followed scrupulously by all concerned. Any deviation will entail individual action as per provisions laid down in DM Act-2005 & u/s 188 IPC.
