





The tenderers shall have to drop tenders into sealed Tender Box kept in office of the CDPO, Bhadrak from dt. 10.03.2021 to dt. 22.03.2021 until 2:00 PM and will be opened on dated 22.03.2021 at 3:00 PM in the office of the Sub-Collector Bhadrak in presence of the Tender Committee members and tenderers or their authorized representatives. The detailed regarding tender documents, terms & conditions & list of item can be obtained from either the office of the CDPO, Bhadrak or Dist. Web Site on payment of Rs. 2500 /- (Rupees two thousand Five hundred) only should be deposited by the tenderers in shape of cheque /D.D in favour of CDPO, Bhadrak towards cost of the tender paper from dt. 10.03.2021 to dt. 22.03.2021 in any working day from 10.00 A.M to 2.00 P.M. The cost of the tender paper is non refundable.
2. The tender papers should be submitted in a sealed cover superscribing in **block letters** such as "TENDER FOR SUPPLY OF STATIONARY ARTICLES FOR AWC S & ICDS, BHADRAK.
3. The Original tender paper should be filled by the tenderer properly & legibly without any correction/overwriting & shall be submitted along with Annexure-1
4. The tender shall quote one rate for one item as per the given specification. The unit rate for the individual sub-items will not be taken into consideration. The final rate including all taxes and transportation charges up to ICDS project Bhadrak.
5. The tender paper will be received through tender box kept in office of the CDPO, Bhadrak by hand/post. The Telegraphic/conditional tender will not be accepted.
6. Earnest money of Rs. 100000/- (Rupees one lakh) only should be deposited by the tenderer in shape of NSC/Term deposit/BD any Nationalised Bank in favour of the CDPO, Bhadrak and it will be enclosed along with tender paper. No tenderer shall be allowed to withdraw his Earnest Money before finalisation of the tender.


