GENERAL CONDITION OF CONTRACT

- 1) The Tenderers are required to deposit Earnest Money (EMD) @1% of the bid amount as in shape of D.D./Bankers Cheque/ NSC / KVP / T.D. duly pledged in favour of Executive Officer, Dhamnagar NAC. Tender received without EMD will not be considered.
- 2) The work is to be completed within the stipulated period as mentioned in the NIT.
- 3) The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
- 4) Conditional tenders containing terms and condition are liable for rejection.
- 5) The Contractors are required to furnish evidence of ownership of machineries such as concrete Mixer, Vibrator, centering materials failing which tenders will not be taken in to consideration.
- 6) The Contractor shall furnish a certificate along with tender to the effect that he is not related to any officer in the rank of Junior Engineer, Assistant Engineer and above. If the fact subsequently proved to be false, the contract is liable to be rejected.

- 15) The Tenderer whose tender is accepted shall forthwith, on written intimation being given to him about acceptance of tender, make requisite initial security deposit and sign the agreement within 7 (Seven) days of such intimation for due fulfillment of contract in the office of Executive Officer, Dhamnagar NAC, failing which it be liable for forfeitures of the earnest money.
