

3. Bids shall be received in the office of the Panchayat Samiti, Dhamnagar, Bhadrak till Dt. **05.04.2021 up to 5.00PM- through Registered Post/ Speed Post.** The authority will not be held responsible for postal delay in the delivering of the documents or non-receipt of the same.
4. The tender will be opened in the office of the Panchayat Samiti, Dhamnagar, Bhadrak at **11.00AM, on 06.04.2021** in presence of the bidders or their authorized representatives. In case of holidays, next working day will be considered.
5. The bid documents can be obtained from the Office of the Panchayat Samiti, Dhamnagar, Bhadrak in person on application and payment of cost of bid documents in **demand draft/Bankers cheque drawn in favour of B.D.O, Dhamnagar, Bhadrak payable at Canara Bank, Kothar .** The bid document can be downloaded from the official web site of Bhadrak District (<http://www.bhadrak.nic.in>). In case of downloaded bid document the cost of bid document should be attached with the bid. The cost of bid document is not refundable. The envelope containing bid document should be superscribed with **"Tender Call Notice Number- 878 / 18.03.2021.**
6. The undersigned reserves the right to negotiate or reject any or all the tenders in the interest of the Govt. with or without assigning any reason thereof. Any dispute in this matter will be settled up under the Jurisdiction of Bhadrak District. **(The bids of the defaulting contractors of this block those who have not completed the work in time are liable for rejection.)**
7. The additional performance security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e estimated cost put to tender – minus the quoted amount as Additional Performance Security (APS) in shape of Term Deposit receipt pledged in favour of B.D.O. Dhamnagar/ Bank guarantee in favour of BDO, Dhamnagar from any Nationalized/ Scheduled Bank in India counter guaranteed by its local branch at Bhubaneswar within seven days of issue of Letter of Acceptance (LoA) by the BDO, Dhamnagar (by e-mail) to the successful bidder otherwise the bid of the successful bidder shall be cancelled and the Earnest Money/ Bid Security shall be forfeited. Further proceeding for blacklisting shall be initiated against the bidder. The concerned APS will be returned to the bidder after completion of work in all respect i.e. Final bill paid.
