

Quotation/ Tender Call Notice

Sealed Quotations/ tenders are invited from interested reputed Travel Agencies/ Tour Operators or private individuals for providing Non AC/AC Diesel/Petrol driven jeep Model vehicle (s) (BOLERO/MARSHAL) to **Chandabali Block** of Bhadrak district on monthly rent/hiring basis having sitting capacity not less than three excluding driver along with all needed equipments and materials needed for operationalisation of MVU in Chandabali Block. There should be space for keeping laboratory equipments and medicine etc. The vehicle owners (s) should agree with the terms and conditions laid down as follows.

1. The vehicle must be in Road Worthy condition shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance, Certificate, Fitness Certificate, valid Contact Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle, obedient and non-alcoholic in nature.
4. A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee, Bank Draft drawn in favour of the CDVO, Bhadrak and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel charges).
6. The vehicle must achieve a fuel efficiency of 10 Kms. Per litre as per Govt. guideline.
7. The details of the make and year of manufacture of the vehicle, registration no., mileage (Kms. Covered per litre) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender.
8. The Quotation completed in all respect should reach the undersigned on or before **07.04.2021** by **11 A.M** and shall be opened on the same day at **12 A.M** in presence of the bidders or their authorized representatives.
9. The application form of quotation/tender containing General Bid information & Terms and conditions for Hiring of Vehicle etc. will be available with CDVO Office of the Deptt./Heads of Department/ Office on payment of Rs.100/- **from 11 A.M. to 5 P.M.**
10. The vehicle will be utilized in all village level of Chandabali Block for treatment of animals in Camp/emergency duty & other A.H. Activities and provide Veterinary Services to the Animals during Natural Calamities like Flood, Cyclone, Draught, Lightning, Heavy Rainfall, Heat wave, Outbreak of Diseases etc. on emergency basis and also attend other works as and when assigned by concerned BVO/Dist. Authority of the Department.
11. The vehicle will be kept in Block H.Qr., V.D. of Chandabali Block.
12. Vehicle will be stickered with logos and information's of A.H. activities, installed with GPS system as and when required as per govt. guideline.
13. The hired vehicle for MVU programme of the block cannot be used for any private /commercial purpose beyond official hours at any circumstances.
14. The Driver of hired Vehicle will be allowed two days off, if there will be no emergency work in the month.
15. The committee has reserved right to cancel any or all tenders without assigning any reason thereof.

16. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.

17. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder immediately.

18. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.

19. The vehicles may have to run as per the terms and conditions issued by the govt. as and when required from time to time.

20. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.


21. In case the service provider/vehicle owner intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to give one month notice before such withdrawal of service and termination of agreement.

22. If the bidder violates any of the terms of contact, Government shall forfeit the entire amount of security deposit.

23. The Department/Office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles (s) or loss of life/injury made to any manner whatsoever. The owner shall be responsible for all such litigation.

24. For providing vehicle (s), separate application need to be submitted along with earnest money for each Block.

25. The Vehicle owners /Bidders must be the inhabitant of **Chandabali Block** preferably.
