ORDER

Whereas, Ministry of Home affairs, Government of India (GOI) has issued guidelines vide Order No.-40-3/2020-DM/1(A)/Dt.23.03.2021, for effective control of COVID-19 to be effective from 1st April, 2021;


And whereas, Govt. of Odisha in Revenue & Disaster Management Department (Disaster Management), Department vide their Order No.1663/R&DM(DM)/Dt.31.03.2021, has issued directives which will be in force from 01.04.2021 to 30.04.2021 and laid down the revised guidelines with stipulations & exceptions of various areas which will be regulated forthwith.

Now therefore, the guidelines issued by Govt. vide Order No.1663/R&DM(DM)/Dt.31.03.2021 will also be applicable in the jurisdiction of Bhadrak Territorial District with following modifications.

- i. For marriage and its related functions, a maximum of 50% of hall capacity with a ceiling of 100 number of persons and for funeral / last rites related gatherings, a maximum of 50% of hall capacity with a ceiling of 50 persons are allowed with prior permission (in writing or electronic communication) of local Police Station with strict adherence to COVID-19 appropriate behavior and maintenance of social distancing. There shall be no marriage procession until further orders. The host shall make necessary arrangements for checking at entry points and ensure wearing of masks by the guests/others during the entire duration of their participation and shall provide masks to those who have not come with appropriate masks. Other conditions as prescribed by the State Government vide order no-4014 /R&DM (DM) dated 6.7.20 for marriage and funeral functions during COVID-19 pandemic shall be strictly followed with above modifications.
- ii. Permission for rallies /processions (if absolutely necessary) with a ceiling of maximum 100 persons may be accorded by IIC of local Police Stations.

- iii. The following kind of functions are strictly prohibited until further orders.
- a. Events/gatherings related to Promotional Activities/ Conferences/ Conclaves etc.
 - b. Centenary/ Golden Jubilee/ Silver Jubilee/ Annual events / functions /celebrations of Educational Institutions/ other Institutions
- iv. For other kinds of social gatherings, the host shall have to obtain specific permission from Sub-Collector-cum-Sub-Divisional Magistrate, Bhadrak with NOC from the concerned IIC of the Police Station which will be given keeping in view the requirement of the host and prevailing pandemic situation subject to maximum participants ceiling of 100 persons.
- v. Permission given earlier if any, regarding number of participants and conduct of functions on and before 03.04.2021 shall stand modified accordingly.

This order shall be implemented with effect.
