NOTICE INVITING APPLICATION FROM RETIRED ENGINEER FOR CONTRACTUAL ENGAGEMENT

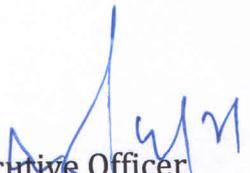

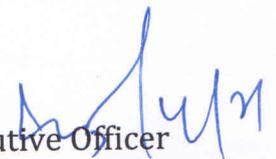
1. Organisation :- Bhadrak Municipality, Bhadrak
2. Qualification & Experience :-
 - The candidate should be a retired Engineer dealt with Civil Engineering works such as Road, Drain, Bridge, Building and other Civil construction work with 20 Years experience in execution of above related works.
 - He should not be above 65 years of age.
 - The applicant should not have pending Vigilance case/ Criminal case against him. Candidate discontinued on account of poor performance of conduct shall not be eligible.
3. The Candidate should have sound health and physically fit to undertake tours/ field visit to different Ward of Bhadrak Municipality .
4. Selection :- The selection of candidates will be made by Selection Committee.

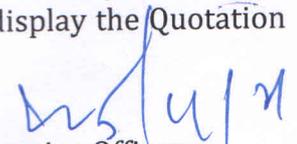
