

Terms and condition for Auction of standing Trees.

01. There are 125 (One hundred twenty five) number of trees to be put to auction for sale.
02. Trees are located in the premises of Main Market Yard, RMC Bhadrak, At-Salandi By Pass in front of Bhadrak Rural Police Station over Plot No-158, 159,160,479,478,480/2321,465/2255 of Khata No-203 under Mouza- Kuansh and Plot No. 305,307,308,311,312,314,315,317,324,328,342,343,319,318 of Khata No. 190 under Mouza Isufpur recorded in the name of Regulated Market Committee Bhadrak.
03. Interested Saw Mill owners / interested parties having GST registration, PAN card and valid Adhar card may submit the quotation in a sealed cover by Regd. Post quoting the maximum price in Indian Rupee to purchase the entire number of trees to the Chairman, RMC, Bhadrak, At-Salandi By Pass, P.O./ Dist- Bhadrak, PIN-756100, Odisha.
04. Quotation for a fraction number of trees will not be sold. The entire 125 number of tree will be sold to the highest bidder.
05. Interest parties can visit the Main Market Yard to see the trees those have been numbered from Sl. No-1 to 129 except Sl. No. 58 to 61 prior to submit their quotation/Bid.
06. The interested parties have to submit their quotations/Bids in the prescribed proforma only.
07. The application fee of Rs 2,500/- (non refundable) in shape of Bank Draft in any scheduled Bank in favour of the Secretary, RMC, Bhadrak payable at Bhadrak should be submitted along with the application.
08. The Security money Rs 30,000/- in shape of Bank Draft in any scheduled Bank in favour of the Secretary, RMC, Bhadrak payable at Bhadrak should be submitted along with the application. The security money is refundable within 15 days from the date of auction.

09. The last date of receipt of quotation/Bid in sealed cover & by Regd. Post is 20.05.2021. Quotation received after last date will not be accepted for auction. The authority is not responsible for any postal delay.
10. The quotations/bids as received will be opened on 21.05.2021 at 11.00 A.M. in the office Chamber of the Sub-Collector, Bhadrak. The bidders or their authorized representatives may attend the opening of quotations/bids as scheduled.
11. In case the highest quotation/bid value is more than one and equal, the transparent lottery will be held to finalise the auction process. The highest bidder is to furnish the quoted price in shape of Bank draft drawn in any scheduled Bank in favour of the Secretary, RMC, Bhadrak payable at Bhadrak after finalization of auction process and for this bidders have to bring the required Bank draft with him to take part in auction process as scheduled.

On failure of production of Bank draft towards value of trees on the same day or cutting down the trees and lifting the same within 10 days by the highest bidder, the security money shall be forfeited. The second highest bidder will be allowed at the rate of highest quotation/bid value to purchase the trees. The terms and conditions will be unaltered as highest bidder.
13. Any dispute is subject to Bhadrak Jurisdiction only.
