



Sealed quotation/tenders are invited from interested reputed Service Providers for providing one number of Tiago/Bolt/Celerio (BS-IV compliant petrol vehicle) (commercial) having sitting capacity not more than 5 including Driver, which shall conform to the Terms and conditions(Annexure-I) for official use of Land Acquisition Officer, Bhadrak on monthly rent basis.

1. The vehicle must be Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The hiring charges do not include fuel(petrol/diesel) which is to be paid separately basing on actual consumption and lubricants as per existing Government norms.
3. The hired vehicle cannot be used for any private/commercial purpose beyond office hours or during holidays.
4. The hiring may be discontinued immediately, when the vehicle is no longer required for office.
5. The driver of the vehicle must have a valid Driving License for driving transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
6. The Driver should be well behaved, gentle and obedient in nature.
7. A sum of Rs.5,000/- (Rupees Five Thousand) only shall be deposited by the intending bidders in shape of A/C Payee Bank Draft drawn in favour of the Land Acquisition Officer, Bhadrak and submitted alongwith the tender as security deposit. After completion of tender process the amount will be refunded to unsuccessful bidders.
8. The monthly rate of hire charges be quoted separately in the general bid information (excluding fuel and lubricant).
9. The vehicle must achieve a fuel efficiency of 17 K.Ms per liter.
10. The details of the make and year of manufacture of the vehicle registration number, mileage (KMs covered per liter) and name of the Driver with Driving license No. and period of validity should be specifically provided in the general bid information to be furnished with the quotation/Tender (Annexure-III)
11. The Quotation completed in all respect should reach the undersigned on or before 16.06.2021 by 10 A.M. and shall be opened on the same day at 12 noon in presence of the bidders or their authorized representatives.
