7. Preference will be given to local bidders first, in case of non-availability of local bidders outside bidders will be taken into consideration.
8. Bidders who qualify technical bid their financial proposal shall only be opened.

15. Only those firms/agencies should participate in the tender who are willing to supply all the items. Firms / agencies who do not quote the rate for all items as per the specification mentioned in technical bid are liable to be rejected.

In case of failure on part of the approved supplier to supply the item as per the supply order within stipulated period the CDMO, Bhadrak shall have the liberty to purchase those items from other sources and the approved suppliers shall be liable to pay the excess amount which this office may have to incur being the difference of actual amount of purchase minus the amount of approved rate. Accordingly, the difference as aforesaid shall be recovered from the approved supplier from the performance security deposit amount.
17. For any dispute decision of CDMO, Bhadrak shall be final.
18. All legal disputes are subject to the jurisdiction of Bhadrak Court only.
