TERMS & CONDITION

- 1- The applicant must be a citizen of India.
- 2- The applicant should have minimum three years experience in pisciculture & sound financial back ground.
- 3- The applicant has to submit the filled in form duly signed along with all requisite documents in a sealed envelope super-scribed with "Auction sale of (Name of the Tank & Place)_____ & _____, Bhadrak", Executive Officer, Bhadrak Municipality, Bhadrak, Pin No-756100.
- 4- The applicant has to deposite a non-refundable sum of Rs. 200/- towards the cost of application in shape of bank draft of any Nationalise Bank in favour of Executive Officer, Bhadrak Municipality payable at Bhadrak.
- 5- The application will be available in the Website w.e.f. 28/07/2021 and the last date of submission of field in application along with all requisite documents is on 27/08/2021 at 5:30 PM.
- 6- The opening of all application will be held publicly on 01/09/2021 for scrutiny & selection of highest bidder.
- 7- The following Upset price has been fixed for the water tank mentioned is as below.

The applicant has to quote more than the Upset price as fixed for the tank failing which the application will be rejected.

- 8- The quoted price offered by the highest bidder will be deposited one time failing which his offer will stand cancelled and E.M.D. thereof will be forfeited. The second highest bidder will be invited to deposit the same amount one time provided that if more than one applicant have quoted same amount then the applicant will be selected by draw of lots.

- 9- An interest free Security deposit at the rate of 10% of the upset price as mentioned against the Tanks shall have to be deposited.
- 10- A Solvency Certificate issued by the Revenue Authority/Bank guarantee valid for a period of one year for an amount not less than the quoted amount is to be submitted.
- 11- There will be 10% hike over the auction price in every successful completion of year & admissible GST rate so fixed by the Govt. from time to time.
- 12- The Rahania Tank shall be used for the purpose of Pisciculture as well as Boating Services for the Rahania Park visitors. The lessee will operate, manage & maintain all activity of boating services including collection of boating fee as fixed by Municipal Council & security, safety and rescue measures of the visitors. Besides this the lessee shall not restraint the beautification as well as any other development work undertaken by the lessor over the remaining portion of the vacant land (other than the water area) of the said Tank during the lease period.
- 13- Maintenance of the Tanks including clearing of weed and its embankment shall be undertaken by the lessee during lease period. The environment of Tank & its embankment should be kept clean, hygienic & eco-friendly.
- 14- The Tank shall be kept open for the Local for bathing and other ancillary purpose. The lessee shall not do anything which will cause infringement of Public right.
- 15- No permanent construction shall be made on the embankment or not cause any damage to existing embankment of the Tank in no circumstance.
- 16- The lessor shall not be held responsible for any type of loss concerning fishing or boating. The lessor reserves the right to revoke license at any time without assigning any reason thereof.
- 17- If any dispute arises during the period of lease, the lessee can appeal before Municipal Council, Bhadrak whose decision is final & binding.
- 18- In case of any violation to any terms of license is noticed at any point of time during period of lease, the decision of the Council shall be final.
