1. The tender format would be downloaded from our website- www.bhadrak.nic.in.
2. Offer should be submitted in sealed envelope and super scribed as "**Tender for Pest- Control & Anti Termite Treatment**". Contact Name & Mobile No. to be provided on the top of the envelope and submitted to O/o the CDM & PHO, Bhadrak, Odisha - 756100. So as to reach their latest by 25.10.2021 (till 5 P. M) through Registered post /courier.
3. CDM & PHO reserves the right to call the firm for negotiation based on the rate quoted on the price bid if deemed necessary.
4. Successful bidder cannot further delegate the work other that assigned by CDM & PHO.
5. The firm should have their own manpower with all technical knowledge with equipments.
6. The firm/agency/Company must have a registered office in Bhubaneswar or cuttack .
7. The Undersigned would not accept/entertain any tender if there is over writing or correction.
8. Any form of canvassing or lobbying shall be seriously viewed .No clarification be sort.
9. The bid should contain the following documents in two packets
10. Enclose a Demand Draft for Rs. 1000/- drawn in favour of the CDM & PHO, Bhadrak towards the cost of Tender Paper. This is non-refundable.
11. Enclose a Demand Draft for Rs. 5000/- drawn in favour of the CDM & PHO, Bhadrak towards Security Deposit. The Demand Draft would be returned to unsuccessful bidders.
12. License from Central Insecticides Board & Registration Committee and Indian pest control association.
13. Valid authorized dealer/service provider certificate, IT Clearance / Valid Sales Tax No./GST No.and up-to-date VAT Clearance Certificate etc. are to be provided.
14. Last date for submission of sealed offer is 25.10.21 till 5P.M.
15. The term of agreement shall be for one year from the issue of offer letter. The contract may be extended for two more years as per the amount decided in the initial agreement.
16. In case a firm fails to execute the works properly as mentioned above, the earnest money will be forfeited.
17. Non Compliance of above terms and condition will make the tender liable for rejection.
18. The firm should have at least 5 years experience in AMC with reputed organization.
19. The firm has to produce minimum five present work orders continuing with the state and central government undertaking or department.
20. The annual turnover of the firm should be more than 10 lakhs (last two years certificate is to be produced).

26. Payment will be made after joint measurement of actual area.
27. All the general and special tools, required for proper pest control/ Termite Treatment shall be arranged by the agency at his own cost.
28. The chemical used should be odour less and as per WHO norms. The banned chemical should not be used in the premises.
29. Selection of the bidders is on the discretion of the CDM & PHO Authority considering the services rendered to different organizations irrespective of the price quoted by the firm.

SECOND ENVELOPE- should contain duly signed (Financial Bid), super scribed as "Financial Bid for -Pest control & Anti-Termite Treatment"

THIRD ENVELOPE- should contain DD for Cost of Quotation Call Paper of Rs.1000/- (Rupees one thousand only) and security deposit of Rs.5000/- (Rupees five thousand only) as cost of EMD to be put in this envelope and sealed.
