The cover containing the bid should be super scribed as Tender for the work "name of the work as the case may be"

Bids must be accompanied with bid security and receipt against cost of bid documents of the amount as specified for the work in the table along bid document's cost of bid documents shall be in shape of demand draft issued from any Nationalized Scheduled Bank located in the state of Odisha in favour of Block Development Officer,Bonth Bid security will have to be valid for 45 days beyond the validity of the bid.
