

Terms & Condition for disposal of condemned vehicles of District Health Department Bhadrak during the current financial year 2021-22 vide tender notice no 11743 dtd 27.10.21

**1. MATERIALS TO BE DISPOSED OFF**

1. Condemned Vehicles /Scrap Vehicles are to be disposed as per location wise as under the Group Annexed.
2. Condemned vehicles /scrap vehicles are to be auctioned as per statement annexed.
3. The participants may inspect the vehicles during the official working hours with permission from the CDM & PHO Bhadrak.
4. Vehicles will be sold in as is where is basis with outstanding taxliabilities.

**2. TENDER FORMS:-**

1. The terms of conditions and guidance of tenders should not be submitted with the TENDER FORMS .Only tender form should be submitted.
2. Tender shall be submitted in the "TENDER FORM" Annexed.
3. The Tenderers will clearly write the group no in the column prescribed ,where they should quote the rate.Any mistake noticed will be decided by the Tender screening committee and its decision will be final.
4. The Tenderers shall quote the rate which should be clearly visible both in figure and words.
5. The Tender paper shall be submitted in sealed cover superscribed "TENDER FOR DISPOSAL OFF EMS AMBULANCE VEHICLE FOR 2021-22"with mention detail address on the cover with their Telephone No./Mobile No.etc. of the tender.
6. All Tenderers shall submit the Tender by registred post/speed /Courier post only.
7. Tenders will be opened on the stipulated date and time by the constituted screening committee comprising of the members of District Level Officers.

### 3. EARNEST MONEY

1. For EMD the bidders shall furnish a bid security declaration in lieu of bid security with stipulation that if they withdraw or modified the bid during period of validity etc, he will be suspended for the time specified in the tender (Annexure-1 C bid security declaration) enclosed.
2. The cost of tender paper amounting of Rs.300/- (Non-refundable) shall be furnish in form of DD only drawn in favour of the CDM & PHO Bhadrak attached in tender paper technical bid.
3. If the successful bidder will withdraw or modify the bid during the period of bid validity within a period of 15 days he will be suspended for applying any tender in Bhadrak district for a period of 3 years starting on the order place date.
4. The Tenderer should clearly mention their name and designation in case of organization, whether it is govt /private organization.

### 4. PAYMENT .ETC

1. In the event of a tenderer not coming forward to deposit the rest 75 % amount due within 15 days i.e from the date of deposit of 25% the conducting Authority will be free to dispose the vehicle to any other party.
2. On receipt of intimation the Tenderer will contact the concerned officer in the office of CDM & PHO Bhadrak obtaining a money receipt after depositing the total amount due.
3. On payment of total amount clearance will be issued by the CDM & PHO Bhadrak.
4. No Tender money will be accepted without the presence of the successful bidder or their authorized bidder or their authorized agents .
5. The vehicles will be handedover to the successful tenderer on receipt of full payment of the accepted tender money.
6. Tools implements and spare parts shall not be delivered, R.C Books etc which are not available shall not be delivered alongwith the vehicle.
7. The Tenderer shall have to take the vehicle from the site mentioned above within 7 days after finalisation of Tender, Custody and safety of the vehicles shall be responsibility of the tenderer after it is finalized.

5. **GROUND RENT**

1. In case of vehicle is not taken within the stipulated period the ground rent @1% of the Tender money shall be charged for each day or part of the day till the vehicle is removed from the site.
2. Where the ground rent so charged exceeds the sale price deposited by the tenderer then he is ceased to have any right on the vehicle .The amount deposited by him shall be adjusted towards the ground rent and the vehicle shall become absolute property of Govt & free from encumbrances and may be disposed by fresh tender or as per decision of consucting authority.

6. **DISQULAIIFICATION**

1. A Tender may be summarily rejected by the screening committee for the following reasons.
2. Tender document without stipulated amount of Tender cost.
3. Tender not submitted in the prescribed Tender form.
4. Tender received beyond the dt and time stipulated.
5. Tenders not submitted in closed sealed cover.
6. Without bid security declaration and tender cost
7. Sealed Tender paper of any of the absentee tenderer may not be opened and returned to them seal intact within 30 days.

7. **CORRESPONDANCE**

1. All Correspondance including the legal complication on the Tender and disposal of the vehicles are to be complied by the concernbed CDM& PHO Bhadrak.

8. **AUTHORITY**

1. The Authority reserves the right to accept or reject any tender or all tenders without assigning any reason thereof and may settle the auction with the highest bidder on negotiation.
2. In case of dispute on any matter the interpretation and decision of the Authority shall be final and blinding and the legal procedures (if any) will be in the jurisdiction of the Bhadrak court of the state of orissa.


