

The cover containing the bid should be super scribed as Tender for the work "name of the work as the case may be"

Bid document consisting of specifications, the schedule of quantities and the set of terms & conditions of contractor and other necessary Documents can be seen in the website www.bhadrak.nic.in or purchased from this office on payment of specified amount (non-refundable) during office hours. The bidders who will done load the documents on line must have to obtain the money receipt towards cost of document from this office before the scheduled time.

Bids must be accompanied with bid security and receipt against cost of bid documents of the amount as specified for the work in the table along bid document's cost of bid documents shall be in shape of demand draft issued from any Nationalized Scheduled Bank located in the state of Odisha in favour of Block Development Officer, Bonth Bid security will have to be vailed for 45 days beyond the validity of the bid. Bids shall be received in the Office of Panchayata Samiti Bonth up to 3.00PM of 30.12.21 except govt holidays.


