 1. **For BDS-** Original BDS degree certificate & mark sheet and registration certificate in dental council of India.

2. For Physiotherapist:-

- Original Bachelor degree in Physiotherapy i.e BPT certificate. and mark sheet (4 year 6 month duration including internship) from a recognized university indicating total mark/ mark secured/ percentage of mark in BPT.
 - In case of marks secured in the form of CGPA, OGPA, DGPA, GPA, CPI etc., an authenticated certificate for conversion of application to percentage of marks shall be submitted at the time of document verification.
 - Certificate towards AICTE/ UGC recognition of institutions/ Universities shall also be submitted wherever applicable,
 - For others the total mark, mark secured related copies must be submitted for calculation of percentage of mark in aggregate.
 - Non submission/ non availability / non fulfilling minimum eligibility criteria w.r.t the advertisement will lead to rejection of candidature.
- (iv) Original Certificate of passing Odia as language subject in the final examination of Class-VII from any school/educational institution of Odisha/Central Govt or passing a test in Odia language in Middle School standard examination conducted by

- S & ME Deptt, Odisha.
- (v) Original Character certificate from the Head of the Institution last studied./ Issued by Gazetted Officer
- (vi) Original Physical fitness certificate from Govt. Hospital.
- (vii) Original Experience & NOC from current Employer if any (Date of issuance of NOC must not prior to the date of Advertisement.)
