NOTIFICATION

Whereas the Notification under section 19(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act,2013 was issued by the appropriate Government for acquisition of private land measuring an area of Ac.28.94 dec in respect of Vill-Kakudigadia,P.S.-Dhamnagar, No.-104, Tahasil:-Dhamnagar, Dist:-Bhadrak for renovation of Rebo-Kapali Drainage Channel vide Declaration No.7059/LA Dated.30.05.2020 of Collector, Bhadrak(appropriate Government) which was published in the Extra Ordinary Issue of Odisha Gazette on dtd.06.08.2020.

And whereas as per section 25 of the said Act, where no Award is made under section 23 of the RFCTLAR&R Act,2013 within twelve months from the date of publication of the declaration under section 19 (I), then such declaration shall be deemed to have been rescinded. The second proviso to sub section (7)of section 19 provides that the appropriate Government shall have the power to extend the period of twelve months, if in its opinion circumstances exist justifying the same;

And whereas, the appropriate Government is of the opinion that circumstances existed for the inadvertent delay for sanction of estimate;

Now, therefore, in exercise the powers conferred by second proviso to sub-section (7) of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act,2013 (30 of 2013), the appropriate Government do hereby decide to extend the period of twelve months from the date of publication of declaration U/S 19(I) of the RFCTLAR&R Act,2013 up to **05.08.2022** for award under section 23 of the said Act.
