TERMS & CONDITIONS

1. The vehicle is to be engaged on the day(s)/ month(s) as will be ordered from time to time and accordingly agreement will be executed by the DPC and the Agency /Owner for a period of one year.
2. The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, Proof of up to date tax payment etc. which are mandatory for plying of vehicle.
3. During night halt extra charges of Rs.100/- per day for non A/C & A/C Hired vehicle will be charged.
4. All repair & maintenance cost will be borne by the Agency/Owner.
5. It will be the responsibility of the Agency/Owner to provide a driver having valid driving license and the salary of the driver will be borne by the owner.
6. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
7. In case of break down for reasons whatsoever the replacement of a vehicle will be done by the Agency/Owner.
8. Payment to be made on monthly basis by A/C payee Cheque only subject to deduction of Service Tax / TDS etc.
9. With quotation paper copies of valid RC, Insurance & other clearance certificates are to be submitted by the agency/vehicle owner.
10. A banner board is to be veiled on the front of the vehicle if hired as "RTE-SS, Bhadrak" School & Mass Education Deptt, Govt. of Odisha.


