AUCTION SALE NOTICE

Seal tender in plain paper are invited by the under signed from intending bidders for purchase of condemned Govt. Vehicle "Mahindra & Mahindra Jeep" bearing No.OR-22-A-9292.

The intending bidder can inspect the vehicle in the Collector Office Bhadrak premises prior to submission of tender paper by them in any working day during office hour.

The intending bidder will have to pay Rs.1000/(Rupees one thousand) only as earnest money through Bank Draft of SBI, Bhadrak payable at Bhadrak in favor of Collector, Bhadrak which will be refunded to the unsuccessful bidder after finalization of the bid. The EMD submitted by the highest bidder will be adjusted against sale price of the vehicle.

The last date of receiving sealed tender/auction in the Collector, Office Bhadrak is on Dt 29.07.2022 till 12 AM at the latest and tender so received shall be opened by the tender committee on the same date i.e. 29.07.22 at 4 PM in presence of the available bidder or their authorized representative. The bidders should subscribe the words "Office for auction sale of condemned Govt. Vehicle with the detail present address and Mobile no" on the sealed cover. The amount offered by the bidders should be written clearly in words and figure. Any deviation in tender and stating facts and figure make them liable for rejection of tender. For the purpose of receiving the Tender a sealed box will be kept at the Collector, Office Bhadrak.

The highest bidder whose tender would be accepted shall deposit immediately 30% of the bid amount as initial deposit. He shall deposit the balance amount within seven days of the deposit of the initial amount and remove the vehicle with permission of the undersigned. In case he/ she fails to make the deposit of the total amount as per the tender within the stipulated time his initial deposit including the earnest money shall be forfeited. GST as admissible shall be levied on the bidding cost. The auction purchaser shall be solely responsible for payment of GST.

In case the bidder whose tender could be accepted fails to remove the vehicle from the office campus within stipulated time he/she shall pay ground rent as permissible. If the ground rent so charged exceeds the amount deposited by the highest bidder then the bidder shall cease to have any right on the vehicle and the amount deposited by the bidder shall be adjusted towards ground rent & the vehicle shall become absolute property of Govt.
