OFFICE ORDER

In pursuance of Odisha District Revenue Service (Method of Recruitment and Conditions of Service) Rules, 1983 and subsequent amendment rules made thereof, the following **18 (Eighteen)** candidates who have come out successful in Combined Recruitment Examination(CRE)-2021 pursuant to Advertisement No.IIE-121/2021/999(C)/ OSSSC Dated 30.09.2021 conducted by Odisha Sub-Ordinate Staff Selection Commission, Bhubaneswar are hereby appointed as **Amin** on regular basis in Cell-1, Level-3 of the first schedule of the Pay Matrix under Odisha Revised Scale of Pay Rules, 2017 as per Odisha Group-"B", "C" and Group-"D" posts (Repeal and Special Provisions) Rules, 2022 notified vide GA & PG Department Notification No.PT1-GAD-SC-GCS-0090-2022-29076/Gen Dated 16.10.2022.

They shall be on probation for a period of two (02) years and their appointment is purely temporary and subject to verification of character and antecedents. On receipt of adverse report on character and antecedents at any point of time during the said period, his/her services shall be terminated forthwith in accordance with the provisions laid down in sub-clause (ii) of clause (h) of Explanation under Rule-13 of the Odisha Civil Service (Classification, Control and Appeal) Rules, 1962 reinforced in G.A Department Resolution No.34438/Gen Dated 20.11.1999.
